### A BILL FOR AN ACT

RELATING TO AQUATIC LIFE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Stretching for more than twelve hundred miles
- 2 in the central Pacific, Hawaiian coral reefs account for about
- 3 eighty-five per cent of all coral reefs in the United States.
- 4 In addition to providing humans with food, reefs protect
- 5 shorelines from erosion and storm damage by dissipating wave
- 6 energy and limiting the impact of waves. Coral reefs are also
- 7 responsible for the sandy beaches enjoyed by state residents and
- 8 visitors alike, as coral fragments, shells, and calcified algae
- 9 are the main components of beach sand.
- 10 Every year, aquatic life is collected on Hawaii's coral
- 11 reefs and shipped to the mainland United States, Europe, and
- 12 Asia for use in hobby aquariums. Because aquarium fish
- 13 collectors are highly selective and often capture large
- 14 quantities of individual fish of high value, the potential for
- 15 over-exploitation is high. Species of interest to aquarium
- 16 trade are often absent or in low numbers in areas frequented by
- 17 collectors.

1	Many coral reef fish and invertebrates have complex
2	relationships with the overall ecology of the reef. Their
3	removal may affect the long-term stability of these ecosystems.
4	For example, approximately eighty per cent of the catch of
5	marine ornamentals is herbivorous fish. A reduction in the
6	abundance of herbivores can cause algal overgrowth of coral,
7	adversely impacting the health of coral reefs.
8	The purpose of this Act is to:
9	(1) Prohibit the taking or harvesting of aquarium fish for
10	commercial sale; and
11	(2) Require the department of land and natural resources
12	to annually report to the legislature regarding
13	applications for aquarium fish permits.
14	SECTION 2. Chapter 188, Hawaii Revised Statutes, is
15	amended by adding a new section to be appropriately designated
16	and to read as follows:
17	"§188- Aquarium fish; taking or harvesting prohibited.
18	(a) It shall be unlawful for any person to take or harvest
19	aquarium fish from state waters for the purpose of selling the
20	aquarium fish.
21	(b) This section shall not apply to the taking or
22	harvesting of aquarium fish for the purpose of scientific study

- 1 or for display in a public aquarium operated for the benefit of
- 2 public education, pursuant to section 188-31.
- 3 (c) For the purposes of this section:
- 4 "Aquarium fish" means salt water fish, freshwater nongame
- 5 fish, or other aquatic life used for aquarium purposes.
- 6 "Aquarium purposes" means to hold salt water fish,
- 7 freshwater nongame fish, or other aquatic life alive in a state
- 8 of captivity as pets, for scientific study, or for public
- 9 exhibition or display, or for sale for these purposes.
- 10 "Take" means to fish for, catch, capture, confine, or
- 11 harvest, or to attempt to fish for, catch, capture, confine, or
- 12 harvest aquatic life."
- 13 SECTION 3. Section 188-31, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§188-31 Permits to take aquatic life for aquarium
- 16 purposes. (a) Except as prohibited by law[-7] and subject to
- 17 section 188- , the department, upon receipt of a written
- 18 application, may issue an aquarium fish permit, not longer than
- 19 one year in duration, to use fine meshed traps, or fine meshed
- 20 nets other than throw nets, for the taking of [marine or
- 21 freshwater nongame fish and other aquatic life for aquarium
- 22 purposes.] aquarium fish for the purpose of scientific study or



- for display in a public aquarium operated for the benefit of 1
- public education. The department shall render a decision on a 2
- 3 completed application for an aquarium fish permit and notify the
- 4 applicant of the decision within ninety days of the department's
- 5 receipt of the application.
- 6 (b) Except as prohibited by law, the permits shall be
- 7 issued only to persons who can satisfy the department that they
- 8 possess facilities to and can maintain fish and other aquatic
- 9 life alive and in reasonable health.
- 10 (c) Where the director determines that public
- 11 participation is appropriate for the issuance of an aquarium
- fish permit, the director may provide public notice and an 12
- 13 opportunity for public comments.
- The department shall submit an annual report to the 14
- 15 legislature no later than February 1 of each year, which shall
- include a record of each aquarium fish permit application 16
- 17 received by the department and the decision rendered for each
- 18 application.
- 19 [(c)] (e) It shall be illegal to sell or offer for sale
- any fish and other aquatic life taken under an aquarium fish 20
- permit unless those fish and other aquatic life are sold alive 21
- 22 for aquarium purposes [-] pursuant to subsection (a).

The department may adopt rules pursuant to chapter 91 (f) 1 2 for the purpose of this section. 3  $[\frac{d}{d}]$  (g) For the purposes of this section: "Aquarium fish" means salt water fish, freshwater nongame 4 5 fish, or other aquatic life used for aquarium purposes. 6 [(1) "Aquarium purposes" means to hold salt water fish, 7 freshwater nongame fish, or other aquatic life alive in a state 8 of captivity as pets, for scientific study, or for public 9 exhibition or display, or for sale for these purposes; and 10 (2) Aquarium fish permit" means a permit issued by the 11 board for the use of fine mesh nets and traps to take salt water **12** fish, freshwater nongame fish, or other aquatic life for 13 aquarium purposes. "Aquarium purposes" means to hold salt water fish, 14 15 freshwater nongame fish, or other aquatic life alive in a state of captivity as pets, for scientific study, or for public 16 exhibition or display, or for sale for these purposes." 17 SECTION 4. Section 189-11, Hawaii Revised Statutes, is 18 19 amended to read as follows: "§189-11 Receipts in duplicate. Every commercial marine 20

10	(B) The numbers of marine life when they average a
11	pound or more; and
12	(C) The price per pound paid; and

16	(4) The signature of the dealer who issues the receipt.
17	Any dealer taking the dealer's own marine life or handling any

- 5 SECTION 5. Section 188-31.5, Hawaii Revised Statutes, is
- 6 repealed.
- 7 ["[\\$188-31.5] Aquarium fish for export; monthly count.
- 8 The department of land and natural resources shall adopt rules
- 9 in accordance with chapter 91 to monitor the aquarium fish catch
- 10 report and fish dealer's report for export of aquarium fish
- 11 taken from the waters of the State for aquarium purposes
- 12 pursuant to section 188-31. A monthly count of the quantities
- 13 taken of each individual species of aquarium fish exported shall
- 14 be reported to the board."]
- 15 SECTION 6. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 7. This Act shall take effect upon its approval.
