A BILL FOR AN ACT

RELATING TO CHILD ABUSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that due to a lack of
- 2 dedicated resources, only about two per cent of known child
- 3 internet crime offenders are being investigated. Alicia's Law
- 4 is an initiative that builds state capacity to combat crimes
- 5 against children by securing funding for internet crimes against
- 6 children task forces. Alicia's Law was named for Alicia
- 7 Kozakiewicz, who was abducted by an internet predator and
- 8 sexually abused.
- 9 The purpose of this Act is to combat internet crimes
- 10 against children by establishing an internet crimes against
- 11 children fee and a special fund to assist law enforcement to
- 12 investigate and prosecute internet crimes against children and
- 13 groups working directly to fight internet crimes against
- 14 children.
- 15 SECTION 2. The Hawaii Revised Statutes is amended by
- 16 adding a new chapter to be appropriately designated and to read
- 17 as follows:

3	§ -1 Short title. This chapter shall be known as and		
4	may be cited as "Alicia's Law".		
5	§ -2 Definitions. As used in this chapter, unless the

8	abuse in the first degree under section 707-750, promoting child		
9	abuse in the second degree under section 707-751, promoting		
10	child abuse in the third degree under section 707-752,		
11	electronic enticement of a child in the first degree under		
12	section 707-756, electronic enticement of a child in the second		
13	degree under section 707-757, indecent electronic display to a		
14	child under section 707-759, or promoting pornography for minors		
15	under section 712-1215.		
16	§ -3 Internet crimes against children fee. (a) The		
17	court shall order every defendant to pay an internet crimes		
18	against children fee of \$ for each felony or misdemeanor		
19	conviction; provided that no fee shall be ordered when the court		
20	determines that the defendant is unable to pay the fee.		
21	(b) When a defendant is also ordered to pay a fine, make		
22	restitution, pay a crime victim compensation fee, or pay other

- 1 fees in addition to the internet crimes against children fee,
- 2 payments by the defendant shall be made in the order of priority
- 3 established under section 706-648.
- 4 (c) The defendant shall pay the internet crimes against
- 5 children fee to the clerk of the court. The fee shall be
- 6 deposited with the director of finance who shall transmit the
- 7 fee to the internet crimes against children special fund
- 8 pursuant to section -4.
- 9 § -4 Internet crimes against children special fund;
- 10 established. (a) There is established in the state treasury
- 11 the internet crimes against children special fund, into which
- 12 shall be deposited:
- 13 (1) All fees collected pursuant to section -3;
- 14 (2) Moneys appropriated by the legislature to the fund;
- 15 (3) Other grants and gifts made to the fund; and

- 18 fund shall be expended by the department of the attorney general
- 19 for the following purposes:

13	SECTION 3. There is appropriated out of the general		
14	revenues of the State of Hawaii the sum of \$ or so much

16	deposited into the internet crimes against children special fund		
17	under section -4, Hawaii Revised Statutes.		
18	SECTION 4. There is appropriated out of the internet		
19	crimes ag	ainst children special fund the sum of \$ or so	
20	much thereof as may be necessary for fiscal year 2014-2015 for		
21	purposes	of providing training and equipment to local law	
22	enforceme	nt, providing law enforcement with funds to investigate

- 1 and prosecute internet crimes against children, and assisting
- 2 groups working directly to combat internet crimes against
- 3 children.
- 4 The sum appropriated shall be expended by the department of
- 5 the attorney general for the purposes of this Act.
- 6 SECTION 5. This Act does not affect rights and duties that
- 7 matured, penalties that were incurred, and proceedings that were
- 8 begun, before the effective date of this Act.
- 9 SECTION 6. This Act shall take effect on July 1, 2050.
