A BILL FOR AN ACT

RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 356D, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§356D- Lease or rent to nonprofit organizations and
5	government agencies. (a) The authority may retain dwelling
6	units or community facilities in a housing project, to the
7	extent it determines necessary and appropriate, for lease or
8	rent to nonprofit organizations and government agencies. The
9	dwelling units or community facilities shall be used by the
10	nonprofit organizations and government agencies to provide
11	housing opportunities and related support services to
12	individuals or families of low income or with special needs.
13	These uses include the use of dwelling units for group homes and
14	congregate living facilities and for government employees
15	providing resident programs and services.
16	The authority, to the extent appropriate, shall have the
17	same powers with respect to nonprofit organizations and
18	government agencies leasing or renting dwelling units as the
