### A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 89, Hawaii Revised Statutes, is amended
- 2 by adding a new section to be appropriately designated and to
- 3 read as follows:
- 4 "\$89- Hearing notice. Notwithstanding section 91-9.5,
- 5 in any hearing conducted by the board pursuant to chapter 91,
- 6 all parties shall be given written notice of the hearing by
- 7 first class mail at least fifteen days before the scheduled date

- 9 SECTION 2. Section 89-9, Hawaii Revised Statutes, is

- 12 "(a) The employer and the exclusive representative shall
