## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR SALARY INCREASES FOR PUBLIC EMPLOYEES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 **PART I**

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums, or so much  
5 thereof as may be necessary, to fund for fiscal biennium 2013-  
6 2015 for all collective bargaining cost items in the agreements  
7 negotiated with the exclusive bargaining representatives of  
8 collective bargaining unit (6):

 18 are excluded from collective bargaining and belong to the same  
 19 compensation plans as those officers and employees within  
 20 collective bargaining unit (6):

14 SECTION 13. Salary increases and cost adjustments provided  
 15 in this Act for any officer or employee whose compensation is  
 16 paid, in whole or in part, from federal, special, or other funds  
 17 shall be paid wholly or proportionately, as the case may be,  
 18 from the respective funds.

19 SECTION 14. Funds appropriated or authorized by this Act  
 20 that are not expended or encumbered by June 30, 2014, and  
 21 June 30, 2015, of the respective fiscal years, shall lapse as of  
 22 those dates.
