14 SECTION 5. Salary increases and cost adjustments provided 15 in this Act for any officer or employee whose compensation is 16 paid, in whole or in part, from federal, special, or other funds 17 shall be paid wholly or proportionately, as the case may be, 18 from the respective funds.

SECTION 6. Funds appropriated by this Act that are not
expended or encumbered by June 30, 2014, and June 30, 2015, of
the respective fiscal years, shall lapse as of those dates.
SECTION 7. This Act shall take effect on July 1, 2013.
