
#### A BILL FOR AN ACT

RELATING TO HAWAII FOOD RESILIENCY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that Hawaii is
3	dangerously dependent on imported food. As the most
4	geographically isolated state in the country, Hawaii imports
5	approximately ninety-two per cent of its food, according to the
6	Pacific Regional Integrated Sciences and Assessments Program.
7	Currently, Hawaii has an inventory of fresh produce that would
8	supply consumers for no more than ten days. Ninety per cent of
9	the beef, sixty-seven per cent of the fresh vegetables, sixty-
10	five per cent of the fresh fruits, and eighty per cent of all
11	milk purchased in the State are imported. The legislature
12	further finds that Hawaii's reliance on out-of-state sources of
13	food places residents directly at risk of food shortages in the
14	event of natural disasters, economic disruption, and other
15	external factors beyond the State's control.
16	The legislature further finds that each food product
17	imported to Hawaii is a lost opportunity for local economic
18	growth. The legislature notes that according to the University

- 1 of Hawaii college of tropical agriculture and human resources,
- 2 an increase in the production and sale of Hawaii-grown
- 3 agricultural commodities would contribute to significant job
- 4 creation. The research shows that replacing ten per cent of
- 5 current food imports with locally grown food will create a total
- 6 of two thousand three hundred jobs. The legislature thus finds
- 7 that increasing the amount of locally grown food by as little as
- 8 ten per cent could keep hundreds of millions of dollars
- 9 circulating within Hawaii's economy, stimulate growth, and
- 10 create thousands of new jobs. Such diversification would help
- 11 make Hawaii's economy more resilient to worldwide events.
- 12 The legislature further finds that increasing local
- 13 production will ensure that Hawaii has food sources that will be
- 14 more resilient to global supply disruptions, will be better able
- 15 to cope with increasing global demand and shortages of
- 16 commodities such as oil, and will be better prepared to deal
- 17 with potential global food scarcities.
- 18 The legislature notes that the nutrients in fresh fruits
- 19 and vegetables degrade rapidly and recognizes that increased
- 20 availability of local food typically ensures access to fresher,
- 21 later-picked produce with greater vitamin content and higher
- 22 nutritional value. A more robust local agricultural sector will





1	lead to more consistency and a likely increase in nutritional
2	choices for local residents. The legislature believes
3	communities will thrive by having a steady, affordable stream of
4	local products that act as staple foods to residents and by
5	having their food dollars recycled and reinvested in the local
6	economy.
7	In summary, the legislature finds that establishing an
8	increase in the production of local food as a key state priority
9	will lead to the diversification of Hawaii's economy, create new
10	jobs, advance Hawaii's long term economic stability, and boost
11	the food security of the people of Hawaii. This Act sets out a
12	specific roadmap to implement the recommendations made by the
13	Hawaii economic development task force created pursuant to Act
14	73, Session Laws of Hawaii 2010; the Hawaii clean energy
15	initiative; the office of planning strategy on increased food
16	security and food self sufficiency published in October of 2012;
17	and the Hawaii 2050 sustainability plan.
18	The purpose of this Act is to:
19	(1) Establish a formal statewide food resiliency
20	initiative that is recognized and supported by the
21	legislature and will achieve measurable goals of food

self-sufficiency in a reasonable timeframe;

2	•	of agriculture to coordinate, promote, and implement
3		the food resiliency initiative according to the
4		initiative's stated benchmarks and goals;
5	(3)	Establish a task force to set forth the specific
6		benchmarks for the food resiliency initiative to
7		achieve and a timeline in which to achieve those
8		benchmarks; and
9	(4)	Provide adequate resources to support the food
10		resiliency initiative.

12	SECT	ION 2. The purpose of this part is to create a food
13	resilienc	y initiative under the department of agriculture and a
14	new branc	h of the department of agriculture to coordinate,
15	develop,	and implement the food resiliency initiative.
16	SECT	ION 3. Chapter 141, Hawaii Revised Statutes, is
17	amended b	y adding a new part to be appropriately designated and
18	to read a	s follows:
19		"PART . FOOD RESILIENCY
20	§1 <b>4</b> 1	-A Definitions. As used in this part:
21	"Dep	artment" means the department of agriculture.

1	"F00	d resiliency" refers to the concept of developing a
2	more sust	ainable and self-sufficient food supply system in
3	Hawaii.	Food resiliency encourages production and consumption
4	of locall	y grown and bred food to decrease the reliance on
5	imported	food, thereby improving the State's economy, health,
6	energy co	nsumption, and general well-being.
7	§1 <b>4</b> 1	-B Hawaii food resiliency initiative. (a) There is
8	establish	ed within the department, a Hawaii food resiliency
9	initiativ	e to increase the State's food security and food self-
10	sufficien	cy. The food resiliency initiative shall design,
11	implement	, and administer activities to:
12	(1)	Increase agriculture sustainability and improve the
13		economic viability of the State's agriculture
14		industry, including development of data to measure
15		progress;
16	(2)	Develop and implement programs to assist farm,
17		nursery, and livestock production;
18	(3)	Coordinate, fund, and establish agriculture industry
19		development programs;
20	(4)	Develop a cross-agency electronic agricultural data
21		system with soil, water, climate, economic, and other
22		relevant data that can be used to make informed

1		agriculture-related decisions and is supported and
2		maintained with sustainable funds;
3	(5)	Partner with the Hawaii clean energy initiative
4		program to further the goals of this part;
5	(6)	Establish Hawaii as a global leader in agriculture and
6		agriculture technologies and a model of food self
7		sufficiency;
8	(7)	Develop and implement concepts and programs to expand
9		the market share of locally-grown agriculture;
10	(8)	Market and promote buying locally grown foods and
11		other local agriculture products;
12	(9)	Support and assist in developing a farm-to-school
13		program;
14	(10)	Develop and implement research and technology transfer
15		programs for varietals, treatment, pest control,
16		diagnostics, and farm inputs;
17	(11)	Support and coordinate with other appropriate programs
18		within the department such as infrastructure
19		development, biosecurity, and food safety;
20	(12)	Ensure the product integrity of agricultural
21		commodities branded as "made in Hawaii" to protect
22		Hawaii's identity as a producer;

1	(13)	Review, coordinate, update, oversee, and comment on
2		government policies that affect the State's
3		agriculture and food security;
4	(14)	Develop a plan, to be implemented from 2013 to 2030,
5		to transition the State to a food resilient economy;
6		and
7	(15)	Develop a plan, to be implemented from 2013 to 2030,
8		to assist each county in transitioning to a food
9		resilient economy.
10	(b)	Prior to the initiation of any activities authorized
11	under sub	section (a), the Hawaii food resiliency task force,
12	pursuant	to part III of Act , Session Laws of Hawaii 2013,
13	shall dev	elop a plan of action with the intent of promoting
14	effective	prioritization and focusing of efforts consistent with
15	the State	's food resiliency initiative.
16	(c)	The department shall submit a report to the
17	legislatu	re no later than twenty days prior to the convening of
18	each regu	lar session on the status and progress of the food
19	resilienc	y initiative that shall include progress toward the
20	initiativ	e's benchmarks and goals. The report shall also
21	include:	

1	(1)	The spending plan of the Hawaii food resiliency
2		initiative;
3	(2)	All expenditures of the agricultural development and
4		food security special fund moneys; and
5	(3)	The targeted markets of the expenditures, including

8		program expenditures, including measurable outcomes.

10	is establ	ished a food resiliency branch within the department's
11	agricultu	ral development division, which shall work to achieve
12	the food	resiliency initiative's benchmarks and goals.
13	(b)	Branch functions shall include:
14	(1)	Oversight and disbursement of the agricultural
15		development and food security special fund;
16	(2)	Food resiliency assessments, technical analyses, and
17		resource development functions, including design,
18		management, and completion of systematic analysis of
19		existing and proposed food resiliency programs;
20	(3)	Evaluation of analyses conducted by government
21		agencies and other organizations regarding food
22		resiliency;

1	(4)	Development and management of programs to encourage
2		public and private exploration, research, and
3		commercial development of food resiliency programs;
4	(5)	Food resiliency partnership and outreach functions,
5		including participation in food resiliency evaluation
6		and demonstration projects, outreach, and other
7		activities to promote technically, economically, and
8		environmentally feasible technologies and projects;
9	(6)	Food resiliency resource, technology, and project
10		viability consultant functions, including serving as a
11		consultant to the governor, public agencies, and

16		initiative activities and programs.
17	(d)	There is established within the department the
18	position	of food resiliency administrator who shall be in charge
19	of implem	enting, coordinating, and supporting the food
20	resilienc	y initiative. The position shall be a full-time
21	position	exempt from chapter 76. The administrator shall work

with and help coordinate efforts between all governmental and

1 non-governmental agencies and programs that may further the 2 objectives of the Hawaii food resiliency initiative so as not to 3 duplicate existing efforts and programs. 4 (e) There are established within the department seven full-time temporary positions to support the planning, 5 coordinating, and implementing of the food resiliency 6 7 initiative. The positions shall be exempt from chapter 76." 8 PART III 9 HAWAII FOOD RESILIENCY TASK FORCE 10 SECTION 4. (a) There is established the Hawaii food 11 resiliency task force within the department of agriculture for 12 administrative purposes. The purpose of the Hawaii food 13 resiliency task force shall be to facilitate the accelerated 14 adoption and completion of measurable benchmarks and goals 15 regarding agricultural infrastructure, development, food 16 resiliency outreach and education, and other measures to meet 17 the purposes of this Act. The Hawaii resiliency task force 18 shall apply an interdisciplinary approach to ensure that the 19 Hawaii's food resiliency initiative integrates and considers 20 already existing programs, research, and achievements in ensuring a feasible, coordinated, and aggressive effort in 21

improving food resiliency. The task force should consider

economic, social, environmental, and cultural goals in 1 2 developing measurable benchmarks for the initiative. 3 The Hawaii food resiliency task force shall consist of 4 the following members: 5 The food resiliency administrator of the food (1)6 resiliency branch of the department of agriculture, 7 who shall chair the Hawaii food resiliency task force; 8 (2) The chairperson of the board of agriculture or the 9 chairperson's designee; 10 The director of business, economic development, and (3) 11 tourism or the director's designee; 12 (4) The director of the office of planning or the 13 director's designee; 14 (5) The chairperson of the board of land and natural 15 resources or the chairperson's designee; 16 (6) The dean of the University of Hawaii college of 17 tropical agriculture and human resources or the dean's 18 designee; 19 (7) Three members to be designated by the speaker of the 20 house of representatives; 21 Three members to be designated by the president of the (8)

senate; and

- (9) A representative from each county's private economic
  development board.
- 3 (c) The Hawaii food resiliency task force's members shall
- 4 serve without compensation but shall be reimbursed for expenses,
- 5 including travel expenses, necessary for the performance of
- 6 their duties.
- 7 (d) In the performance of its duties, the Hawaii food
- 8 resiliency task force shall consult with appropriate private,
- 9 nonprofit, community, and government stakeholders.
- (e) The department of agriculture may contract with the
- 11 University of Hawaii for any services to support the work of the
- 12 Hawaii food resiliency task force.
- 13 (f) The Hawaii food resiliency task force shall submit a
- 14 plan setting forth the specific, measurable benchmarks for the
- 15 food resiliency initiative to achieve, and a timeline in which
- 16 to achieve those benchmarks, to the legislature no later than
- 17 twenty days prior to the convening of the regular session of
- 18 2014. The plan shall include a report of how the task force
- 19 came to develop the specific benchmarks and goals within the
- 20 plan and recommendations on how to facilitate the plan.

1	The task force shall also submit a follow-up report to the
2	legislature no later than twenty days prior to the convening of
3	the regular session of 2015.
4	(g) The Hawaii food resiliency task force shall cease to
5	exist on June 30, 2016.
6	PART IV
7	SECTION 5. The purpose of this part is to provide adequat
8	resources to support the food resiliency initiative, including
9	agricultural infrastructure and development to improve food
10	self-sufficiency in Hawaii.
11	SECTION 6. Section 141-10, Hawaii Revised Statutes, is
12	amended by amending subsection (c) to read as follows:
13	"(c) Subject to legislative appropriation, moneys in the
14	special fund may be expended for the following purposes:
15	(1) The awarding of grants to farmers for agricultural
16	production or processing activity;
17	(2) The acquisition of real property for agricultural
18	production or processing activity;
19	(3) The improvement of real property, dams, reservoirs,
20	irrigation systems, and transportation networks
21	necessary to promote agricultural production or
22	processing activity, including investigative studies

1		to identify and assess necessary improvements to dams,	
2		reservoirs, irrigation systems, and transportation	
3		networks;	
4	(4)	The purchase of equipment necessary for agricultural	
5		production or processing activity;	
6	(5)	The conduct of research on and testing of agricultural	
7		products and markets;	
8	(6)	The funding of agricultural inspector positions within	
9		the department of agriculture;	
10	(7)	The promotion and marketing of agricultural products	
11		grown or raised in the State;	
12	(8)	Water quality testing and improvement; [and]	
13	(9)	The funding of positions within the department of	
14		agriculture to implement, coordinate, and support the	
15		Hawaii food resiliency initiative established by	
16		section 141-B; and	
17	[ <del>(9)</del> ]	(10) Any other activity intended to increase
