### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Chapter 421I, Hawaii Revised Statutes, is SECTION 1. 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Adoption of rules; prohibition of smoking "§**421I**− 5 permitted. Unless otherwise prohibited by the articles of 6 incorporation or bylaws, a corporation may adopt rules to 7 prohibit tenant shareholders, guests, and all other persons from 8 smoking in dwelling units, common elements, or limited common 9 elements of the corporation if a majority of tenant shareholders 10 in the corporation has approved such a smoking prohibition." 11 SECTION 2. Section 514B-105, Hawaii Revised Statutes, is 12 amended by amending subsection (b) to read as follows: 13 "(b) Unless otherwise permitted by the declaration, 14 bylaws, or this chapter, an association may adopt rules [and regulations] that affect the use of or behavior in units that 15 16 may be used for residential purposes only to: 17 Prevent any use of a unit [which] that violates the (1)18 declaration or bylaws;
