WHEREAS, Director Fuddy also made significant contributions to building the capacity of the public health workforce, and



earned the respect of numerous public health practitioners and academics; and

WHEREAS, Director Fuddy's distinguished career was due in part to the outstanding education she received in her formative years; she was an alumnus of Sacred Hearts Academy, the University of Hawaii at Manoa, and Johns Hopkins University; and

WHEREAS, under Director Fuddy's watch, according to the United Health Foundation's America's Health Rankings: A Call to Action for Individuals & Their Communities, the State of Hawaii ranked as the healthiest state in the U.S. in 2013; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-seventh Legislature of the State of Hawaii, Regular Session of 2014, that this body hereby recognizes and honors the late Hawaii Department of Health Director Loretta Jean Deliana Antone Fuddy for the legacy she leaves behind in promoting the health and well-being of the people of Hawaii, and extends to her family its deepest condolences for their loss; and
