Your Committee on Finance, to which was referred H.C.R. No. 88 entitled:

"HOUSE CONCURRENT RESOLUTION ENCOURAGING THE CONTRACTORS LICENSE BOARD TO RECONSIDER ITS OCTOBER 18, 2013, FINAL ORDER AND FOLLOW LEGISLATIVE INTENT AND THE HAWAII SUPREME COURT'S RULING THAT THE "INCIDENTAL AND SUPPLEMENTAL" EXCEPTION FOR SPECIALTY CONTRACTORS TO COMPLETE WORK FOR WHICH THEY ARE UNLICENSED IS VERY LIMITED IN SCOPE,"

The purpose of this measure is to encourage the Contractor's License Board to reconsider its October 18, 2013, final order and follow legislative intent and the Hawaii Supreme Court's ruling that the "incidental and supplemental" exception for specialty contractors to complete work for which they are unlicensed is very limited in scope.
