DECISION MAKING ON THE FOLLOWING MEASURE(S):

RELATING TO LIQUOR TAX LAW. SB3041 CPN, WAM Status and Testimony Defines "barrel", "small brewery or brewpub", "small winery", and "small manufacturer". Establishes a tax rate of 23 cents per wine gallon on draft beer and beer other than draft beer that are brewed or produced by a small brewery or brewpub. Establishes a tax rate of 59 cents per wine gallon on still wine and sparkling wine produced by a small winery. Establishes a tax rate of \$2.57 per wine gallon on distilled spirits produced by a small manufacturer. SB2345 RELATING TO THE INVESTOR EDUCATION PROGRAM. HMS/CPN, WAM Status and Testimony Appropriates funds for the continued operation of the investor [Measure added on education program, targeted to kupuna, within the department of 2/11/2014] commerce and consumer affairs office of the securities commissioner. SB2374 RELATING TO CHILD WELFARE. HMS/CPN, JDL Status and Testimony [Measure added on Increases training requirements for court appointed child custody evaluators. Establishes child custody fact finder requirements and 2/11/2014] duties. SB2004 RELATING TO HOME CARE LICENSING. HMS/CPN, WAM Status and Testimony Extends the sunset date of Act 21, First Special Session Laws of [Measure added on Hawaii 2009, which requires home care agencies to be licensed by 2/11/2014] the department of health and makes various conforming amendments.
