### **RELATING TO EDUCATION.**

Allows department of education employees and agents to volunteer to administer epinephrine to a student in anaphylactic shock. Requires the department of health to provide proper instruction and training to every employee or agent who volunteers to administer glucagon and epinephrine. Requires a student's parent or guardian to provide the department of education with written authorization for auto-injectable epinephrine and to supply injectable epinephrine supplies to administer the epinephrine. Makes an appropriation for required instruction, training, and related expenses.

#### **RELATING TO MINORS.**

Prohibits teachers and persons who are licensed to provide professional counseling from engaging in sexual orientation change efforts with a person under eighteen years of age.

### DECISION MAKING TO FOLLOW
