Allows the Hawaii Housing Finance and Development Corporation to issue bonds to eligible developers for infrastructure on land owned by the eligible developer for the construction of affordable housing. <u>HB 2037, HD1</u> (HSCR165-14) <u>Status</u>	RELATING TO PROJECT KEALAHOU. Appropriates funds for the continued funding of Project Kealahou within the Child and Adolescent Mental Health Division of the Department of Health. Effective July 1, 2050.	HLT, FIN

<u>HB 1713</u> (HSCR328-14) <u>Status</u>	RELATING TO AGING. Appropriates general funds to provide ongoing financial support to healthy aging programs and services. Requires the Executive Office on Aging to conduct a public education and awareness campaign on long-term care and appropriates general funds for its support and evaluation. Effective July 1, 2014.	HLT, FIN
HB 2053, HD1 (HSCR104-14) Status	RELATING TO AGING. Establishes a Fall Prevention and Early Detection Coordinator position within the Department of Health's Emergency Medical Services and Injury Prevention System Branch. Appropriates funds. Effective July 1, 2050.	HLT, FIN
<u>HB 2056, HD1</u> (<u>HSCR254-14)</u> <u>Status</u>	RELATING TO AGING.
