<u>SB 2598, SD1, HD1</u> (<u>HSCR1160-14)</u> <u>Status</u>	RELATING TO THE CULTURAL EXCHANGES BETWEEN HAWAII AND AFRICAN AMERICANS. Establishes the Hawaii commission on African American History and Culture to recognize the contributions of the African American people in Hawaii and educate residents and visitors to the State about these contributions. Appropriates funds to the Governor for the expenses of the commission. Effective July 1, 2050.	VMI, FIN
<u>SB 3125, SD2, HD1</u> (HSCR1161-14) <u>Status</u>	RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS. Requires the Auditor to conduct a financial and management audit of the State Foundation on Culture and the Arts.	VMI, FIN
<u>SB 2902, SD1, HD1</u> (<u>HSCR1121-14)</u> <u>Status</u>	RELATING TO MOTOR VEHICLE INSPECTIONS. Expands the authority of the director of transportation over required motor vehicle and motor carrier vehicle inspections in the State. Effective July 1, 2014.	TRN/CPC, FIN
<u>SB 3053, SD2, HD1</u> (<u>HSCR1120-14)</u> <u>Status</u>	RELATING TO UNMANNED AERIAL SYSTEMS TEST SITES. Establishes the Hawaii unmanned aerial systems test site chief operating officer position to, among other things, serve on the Pan- Pacific Unmanned Aerial Systems Test Range Complex management team. Establishes an advisory board to oversee and manage unmanned aerial systems test site operations. Appropriates funds to staff and operate Hawaii's unmanned aerial systems test site activities. <u>SB 2731, SD2, HD1</u> (HSCR1026-14) <u>Status</u>	RELATING TO A CAR-SHARING VEHICLE SURCHARGE TAX. Establishes a car-sharing vehicle surcharge tax. Effective January 1, 2015.	TRN, FIN
<u>SB 2134, SD1</u> (HSCR998-14) <u>Status</u>	RELATING TO EDUCATION. Amends various sections of chapter 302A, HRS, to comply with the requirements of the federal Individuals with Disabilities Education Act. Effective 7/1/2050.	EDN, FIN
<u>SB 2288, SD2, HD1</u> (HSCR996-14) Status	RELATING TO EDUCATION. Amends or repeals various provisions of Chapter 302A, Hawaii Revised Statutes, governing the Department of Education, for housekeeping and other purposes. Effective July 1, 2050.	EDN, FIN
<u>SB 2516, SD2</u> (<u>HSCR1047-14)</u> <u>Status</u>	RELATING TO FACILITIES FUNDING FOR CHARTER SCHOOLS. Appropriates funds for the state public charter school commission to allocate to charter schools for facilities projects based, in part, on the need and performance of the charter schools. Requires annual reporting to the legislature. Effective 7/1/2050.	EDN, FIN
<u>SB 2517, SD2</u> (<u>HSCR1068-14)</u> <u>Status</u>	RELATING TO CHARTER SCHOOLS. Authorizes the state public charter school commission to request the issuance of general obligation bonds from the director of finance and to allocate the proceeds for the design, planning, construction, repair, and maintenance of public charter school facilities. Creates a working group to determine criteria for and to prioritize the allocation of general obligation bond proceeds to the public charters schools. Specifies that public charter school facilities funded through the proceeds of general obligation bonds are owned by the State. Requires the state public charter school commission to report annually to the legislature. Authorizes the issuance of general obligation bonds to the state public charter school commission. Repeals on 6/30/2024. Effective 7/1/2050.	EDN, FIN
<u>SB 2423, SD2</u> (HSCR999-14) <u>Status</u>	RELATING TO THE DEPARTMENT OF EDUCATION. Allows schools and classes to participate in fundraising or charitable activities, in conjunction with a charitable organization that is a 501(c)(3) tax-exempt organization and registered under section 467B- 2.1, HRS, or granted an exception from registration under section 467B-11.5, HRS, based on criteria established by the board of education. Effective 7/1/2050.	EDN, FIN
<u>SB 2768, SD2, HD1</u> (<u>HSCR1051-14)</u> <u>Status</u>	RELATING TO KINDERGARTEN. Amends the compulsory education law to make kindergarten mandatory. Develops a statewide individualized kindergarten readiness system and establishes an individualized kindergarten readiness assessment system. Appropriates funds. Effective July 1, 2014.	EDN, FIN
