<u>SB 2397, SD2</u> (HSCR1071-14) Status	RELATING TO ECONOMIC DEVELOPMENT. Creates an agricultural technology park under the high technology development corporation. Designates certain properties to be included in the park. Makes an appropriation. Effective 7/1/2050.	EDB/AGR, FIN
<u>SB 3066, SD2, HD1</u> (HSCR1181-14) <u>Status</u>	RELATING TO THE PUBLIC-PRIVATE FINANCE INITIATIVE. Establishes the public-private finance initiative (PPIA). Requires the Board to consider altering the Executive Director's benefits package in exchange for a salary that exceeds the salary level of civil service employees. Effective July 1, 2114. <u>SB 2916, SD2, HD1</u> (HSCR1184-14) <u>Status</u>	RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM. Requires ERS to require any department or agency of the State or 'counties to furnish to the system certain payroll and personnel transaction information, including changes or errors in payments. Provides that if a department or agency fails to provide the information in the required format, the State or county is required to pay to the system an amount equal to the employer contributions payable by the department or agency. Provides that unpaid amounts shall bear interest. Allows ERS to waive department or agency requirements paying employer contributions due to unforeseen circumstances. Requires reporting. <u>SB 2609, SD1, HD1</u> (HSCR1182-14) <u>Status</u>	RELATING TO MINIMUM WAGE. Increases minimum wage rate to \$7.75 per hour beginning on 1/1/15, \$8.50 per hour beginning on 1/1/16, \$9.25 per hour beginning on 1/1/17, and \$10.10 per hour beginning on 1/1/18. Increases the tip credit to 50 cents per hour beginning on 1/1/15, 75 cents per hour beginning on 1/1/16, and \$1 per hour beginning on 1/1/17 if the gross amount the employee receives in wages and tips is at least 250 per cent of the poverty level for each calendar year based upon the United States Department of Health and Human Services poverty guidelines for Hawaii.
