<u>SB 2470, SD1</u> (SSCR2466) Status RELATING TO THE HAWAII HEALTH CONNECTOR.

Effective July 1, 2014, lowers the number of members on the board of directors of the Hawaii health connector to twelve, with a maximum of nine total voting members. Removes members representing insurers and dental benefit providers from the board. Requires the governor to designate a state agency representative to serve as the official voting state representatives to be ex officio nonvoting members. Requires the governor to notify the chair of the board regarding the selection of the designated voting and nonvoting state representative members of the board. Establishes procedures for filling vacancies on the board. Effective 07/01/2050. (SD1)
