RELATING TO ANIMAL CRUELTY.
Prohibits the slaughtering or trafficking of pet animals for human consumption. Includes dogs and cats, whether or not bred for human consumption, in the definition of "pet animal". (SB2026 HD1)

Status

RELATING TO PROCUREMENT.
Prohibits the inclusion in any public works contract less than \$10,000,000 between any governmental body and a licensed design professional of a requirement that the contractor defend the governmental body from claims arising out of the contractor's performance under the contract unless the contractor is at fault. Effective December 21, 2112. (SB2463 HD1)

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:
