Status Removes the superintendent of education from the Kaneohe bay regional council. Deletes the requirements that the chairperson of the

council be a nongovernmental member and that the chairperson may not serve more than 2 consecutive years. Deletes the requirement that the council hold annual hearings on the status of the master plan. Requires the council to review and report on the continued relevance

and need for changes in its powers, duties, and functions.
