HB 1582 Status

### **RELATING TO APPLICATION PROCESSING.**

Establishes a maximum time period within which an application for permit, license, or approval shall be acted upon by the designated agency or else deemed granted; authorizes each county to contract with a third-party reviewer to streamline the processing of applications; clarifies that previously approved projects that do not impact historic properties are not subject to subsequent reviews by SHPD.

HB 1901 Status

### RELATING TO WILDLIFE.

Authorizes BLNR to enter into memoranda of understanding, agreement, or mutual aid compact with other states and jurisdictions for the mutual enforcement of hunting, fishing, and other wildlife laws, including the wildlife violators compact. Requires BLNR to enter into the wildlife violators compact and adopt necessary rules.

<u>HB 1905</u> <u>Status</u>	RELATING TO HUNTING. Requires the DLNR to issue Hawaii hunting participant permits authorizing children to hunt under direct supervision. Effective 07/01/2014.	WAL, JUD
