Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations and a brief comment. Mr. Speaker, this bill bumps the cap of the Superintendent of Education to \$250,000, a quarter-million dollars, Mr. Speaker. According to national trends this is no big deal, but I think in Hawaii it's a big deal. And I think, as it was vetoed before, it needs to be looked at very, very closely.

"Mr. Speaker, when we look at what has been overpaid corporate, academic and other things, we don't get results by the amount of money we pay. It makes a huge difference. For example, Mr. Speaker, are you the Speaker because of what you get paid? No. Are we in this Body because of what we get paid? No. In fact, we all have a vow of poverty, so to speak. Because we love it and we know that we're called to do this stuff. And I

don't think you get a superintendent who's a mercenary who will only go by the dollar amount, as to what should be best for our children.

"So, Mr. Speaker, I've got some mixed feelings and I'll start out with reservations, but I think we need to examine this. Look, mainland standards are one thing, but Hawaii culture, trends and other situations. For example, the University of Hawaii, it's very unlikely they're going to have a mainland president. Probably for the Board of Education that is also true. So using the mainland mean, I'm not sure is directly relevant. For those reasons, with reservations for the time being."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2257, entitled: "A BILL FOR AN ACT RELATING TO DEPARTMENT OF EDUCATION SUPERINTENDENT'S SALARY," passed Second Reading and was referred to the Committee on Labor & Public Employment, with Representative Yamane being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 120-14) recommending that H.B. No. 1925, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1925, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Cabanilla.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I'd like to cast a no vote. Just briefly in opposition, I think it's certainly a well-intended measure, but I object to the mandating, if you will, private schools to do this. Many parents remove their kids from public school and put them in private schools so they have more instruction time. We're taking away from instruction time. And again, it's a private school. So, the underlying measure for public schools is fine, but this isn't something like a fire code. This is going beyond that, and so I realize it's probably already being done, but let's keep our hands out of private schools. Thank you."

Representative Fukumoto rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Fukumoto's written remarks are as follows:

"Mr. Speaker, I rise with reservations on House Bill 1925 HD1. This bill requires the administration of the Youth Risk Behavior Survey to students in grades six to twelve in public and private schools, and it requires parents to opt their children out of the survey if they don't want them to participate.

"The Youth Risk Behavior Survey is an excellent tool for better understanding the needs of our *keiki* and the rate at which they are participating in potentially dangerous behaviors. Currently, this survey is administered in some of our schools, but it is an opt-in process for parents rather than an opt-out process. While I personally would not have a concern with my child participating, I know that there are some parents that would not want their children to take the survey.

"I understand that many students who don't participate are not doing so simply because their parent missed the opportunity to opt-in and that their parent may not actually have any concerns with the survey. While I understand that the department would like this change to see more students participate in order to develop better metrics on risky behaviors, my reservations are that the change from an opt-in to an opt-out will be seen as a further reduction of parental rights at a time when many parents in my community are already concerned.

"Thank you, Mr. Speaker."

Representative Fale rose in opposition to the measure and asked that the remarks of Representative McDermott be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B.
