

## TWENTY-FIRST DAY

**Tuesday, February 18, 2014**

The invocation was delivered by Mr. Flynn Corsin, Mr. Van Velasco, Mr. Loren Otake and Students from Pacific Buddhist Academy, after which the Roll was called showing all Members present with the exception of Representative Cachola, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twentieth Day was deferred.

**KA HUA 'ŌLELO O KA LĀ  
HAWAIIAN WORD FOR THE DAY**

Representative Hanohano presented *Ka Hua 'Ōlelo O Ka Lā*, the Hawaiian Word for the Day, as follows:

"*Mahalo ho'omalu 'ōlelo.*  
*Ka hua 'ōlelo o ka lā – 'Ala'ala.*  
*'Ala'ala* – Ink sac in octopus or squid; after salting, drying, and broiling on the fire, it is mixed with *'inamona* or chili pepper *nioi*, and eaten; useless; scar; aerial tubes of bitter yam.  
*Ahu ka 'ala'ala!* Just a pile of squid ink. No use.  
*He aha ka 'ala'ala o kēnā mea āu i ho'i ho'i mai nei?* What's the good of that octopus ink sac you brought home? Useless?  
*He aha kāna 'ala'ala?* What's he good for? Nothing, useless?  
*'Ala'ala, 'ōia ka hua 'ōlelo o ka lā.* Ink sac in octopus or squid, useless, the Hawaiian word for the day. *Mahalo.*"

No. 2560, HD 2, entitled: "A BILL FOR AN ACT RELATING TO FAMILY CHILD CARE HOMES," passed Third Reading by a vote of 49 ayes, with Representatives Cachola and Souki being excused.

Representative Brower, for the Committee on Tourism, presented a report (Stand. Com. Rep. No. 555-14) recommending that H.B. No. 286, as amended in HD 1, be recommitted to the Committee on Tourism.

On motion by Representative Saiki, seconded by Representative Cabanilla and carried, the report of the Committee was adopted and H.B. No. 286, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TOURISM," was recommitted to the Committee on Tourism, with Representatives Cachola and Souki being excused.

## THIRD READING

## H.B. No. 2071, HD 1:

Representative Saiki moved that H.B. No. 2071, HD 1 pass Third Reading, seconded by Representative Cabanilla.

Representative Takai rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Takai's written remarks are as follows:

"Mr. Speaker, I rise in support of HB2071.

"There is no greater sacrifice that one can give, than one who has laid down their life for another family member, friend, or country. The foundation of the United States of America is built by brave individuals who have risked or gave the ultimate sacrifice. It would be a tragedy to overlook these brave individuals and to not recognize what they have done. After all, America is 'Home of the Free because of the Brave.'

"Gold Star Family Day is one of those ways to honor and respect the fallen. Though to take it one step further; Gold Star Family Day not only recognizes the fallen soldier, rather it recognizes the family of the fallen as they must carry the burden of losing a loved one for the rest of their lives. Gold Star Family Day was originally intended to honor the mothers of the fallen soldiers, as it was named 'Gold Star Mother's Day;' this was until President Barack Obama renamed it 'Gold Star Mother's and Family's Day,' thus including the entire family of the fallen. There is now a total of seven states that recognize Gold Star Mother's and Family's Day, they are Illinois, North Dakota, New Jersey, New York, Ohio, Tennessee, and Wisconsin and also Guam.

"Hawaii Gold Star father Allen Hoe stated that Gold Star Family Day 'is a very fitting tribute and a way to remind all of us that freedom is not free.' Support Coordinator Catherine Ignacio from the Survivor Outreach Services stated that passing the bill will not only show continuous support from our Legislature and serve as a constant reminder of the sacrifices our service members and families made, but is also a true way of honoring those who made the ultimate sacrifice for our wonderful nation. Hawaii Gold Star wife Brandy Williams lost her husband Sgt. Eugene Williams in Najaf, Iraq in support of Operation Iraqi Freedom. Sadly, he was Killed In Action by an Improvised Explosive Device on March 29, 2003. Eva Andrade, the Executive Director of the non-profit organization known as Hawaii Family Forum stated, we are very mindful of the sacrifice of every mother and father who has lost a son or daughter to the ravages of war. These lives are precious and their names and memory are etched in history even as far as the Revolutionary War. We honor these heroes as their lost lives remain the bedrock for the United States of America and the freedoms we cherish.

"Therefore the intent of this bill is to establish the last Sunday in September as 'Gold Star Family Day,' a day for the people of Hawaii to recognize and honor the family members of men and women who have bravely given the ultimate sacrifice, their life. Their legacy is carried on through their families and it is our duty to honor these true heroes, the warriors whom we all should look up to with respect and honor.

"Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 2071, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GOLD STAR FAMILY DAY," passed Third Reading by a vote of 49 ayes, with Representatives Cachola and Souki being excused.

#### **H.B. No. 2320, HD 1:**

Representative Saiki moved that H.B. No. 2320, HD 1 pass Third Reading, seconded by Representative Cabanilla.

Representative Belatti rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Belatti's written remarks are as follows:

"I rise in support of House Bill 2320, House Draft 1 that establishes health equity as a goal for the Department of Health and requires the Department to consider social determinants – such as the social and physical environment, health services, and structural and societal factors – when assessing the health needs of the state.

"In July 2013, a report published in the Journal of the American Medical Association revealed shocking and unsettling facts about health inequalities in our country. People who live in wealthy areas like San Francisco and in the suburbs of D.C. are likely to be as healthy as the residents of Japan and Switzerland are. However, those who live in Appalachia and the rural South share their health status with those who

live in Algeria and Bangladesh. NBC News called it 'death by zip code' where health disparities are correlated with social determinants such as access to housing, education, transportation, social services, recreation, and employment.

"With similar income disparities between communities throughout Hawaii, it is important for the state to consider as a matter of official policy the effect that these social determinants have on the health status of individuals, families, and communities. The language in HB 2320, HD 1 encourages a 'Health in All Policies' framework and collaborative approach to improving population health by granting the Department of Health the authority and obligation to consider and address root causes of health disparities and empowering the Department of Health to raise and embed these considerations into their health planning and policymaking for the state."

The motion was put to vote by the Chair and carried, and H.B. No. 2320, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Third Reading by a vote of 49 ayes, with Representatives Cachola and Souki being excused.

#### **H.B. No. 1966, HD 1:**

On motion by Representative Saiki, seconded by Representative Cabanilla and carried, H.B. No. 1966, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC EMPLOYEES," passed Third Reading by a vote of 49 ayes, with Representatives Cachola and Souki being excused.

At 12:33 o'clock p.m., the Chair noted that the following bills passed Third Reading:

### **SUSPENSION OF RULES**

On motion by Representative Cabanilla, seconded by Representative Fukumoto and carried, the rules were suspended for the purpose of considering a certain House Bill for Final Reading by consent calendar. (Representative Cachola was excused.)

### **FINAL READING**

Representative Saiki moved to agree to the amendments made by the Senate to the following House Bill, seconded by Representative Cabanilla:

H.B. No. 2353, (SD 1)

Representative Hanohano rose to speak in opposition to the motion, stating:

"*Mahalo ho'omalū 'ōlelo. Makemake au e koho kako'o 'ole.* Thank you, Mr. Speaker. I am in opposition. *O keia pila ho'o punipuni nui nā kālā e lima me lūne. 'elima miliona kalā 'ano nunui kēia pu'u kala Pehea la ka po'e 'ili hune, ka po'e a'ohē wahi he no ho, ka po'e a'ohē mea ai.*

"This bill is not really a truthful bill for the people of the State of Hawaii. It was going to cost us \$5 million. What about the children, the people that have no food. They're homeless and they have no place to stay. We haven't even fixed all of those problems, yet we're willing to give \$5 million for our airports? What is more important in the State of Hawaii? Airports versus our people, who are definitely in need of food, shelter, the basic necessities? I have examples of that. We cannot even get water for people that need to be on water lines. We cannot even get sewage lines fixed because of the jurisdictions. It's a county versus, like DHHL,

Papakolea. What are we doing here? This is absolutely a stealing of our people's money.

"Five million dollars for airports. What about our poor people who never ever use the airports? What are they going to say? What about those that live out off the grid, live in shacks, so the urban people would say? But yet, that's the way they live. And yet, we cannot even help those people? This is so absolutely unnecessary. We cannot even fix the school systems. It's so *hewa*, so wrong. We cannot even fix Hawaiian language immersion programs for their testing on the assessments. I had a group of *keiki* come in crying, they couldn't even understand the testing. And yet we spent about \$10 million on the testing.

"This is so *hewa*. I could go on and on of all the different faults that government hasn't been doing and not doing their *kuleana*. My *kuleana* here, I know what it is. It's to represent the people that elected me, and to represent all of Hawaii. Whether they're native Hawaiians, our immigrants from the Philippines, our Korean brothers and sisters, our Marshallese people, everyone. But yet this bill is just to make an emergency appropriation for security at Honolulu International Airport. And remember, we did not start the war, 9/11. This is absolutely *ho'opunipuni Mahalo*."

The motion was put to vote by the Chair and carried, and the House agreed to the amendments to the noted House Bill. (Representative Hanohano voted no, and Representative Cachola was excused.)

#### H.B. No. 2353, SD 1:

Representative Saiki moved that H.B. No. 2353, SD 1 pass Final Reading, seconded by Representative Cabanilla.

Representative Yamane rose to speak in support of the measure, stating:

"Mr. Speaker, standing in support. Mr. Speaker, I just want to clarify the measure before you. It is an emergency appropriation of \$5 million. It is being transferred from the special fund and the requirement to do this was to make sure that our airports comply with federal law. So, we are required to do that in order to make sure that our airports are funded with federal match, as well as it meets all the Department of Homeland Security requirements.

"Members, it is a large amount. However, we have a number of airports which are key focal points for inter-island transit, as well as for one of our most important financial drivers, which is our tourism. So, Members, this \$5 million was not used lightly. It was used out of necessity to make sure that we comply with all the federal requirements, to make sure that our airports stay open. That way both our *kama'aina* as well as our visitors can use it. Thank you."

Representative Hanohano rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. Just a slight rebuttal, in opposition. We have airports on DHHL lands, that haven't received any monies. We have landing fees that still need to be collected from the feds. So, I'm still in opposition. And *ho'opunipuni keia pila*. This bill is so wrong, because we haven't even given monies to DHHL for their lands. The feds haven't given us monies for our landing fees.

"So, what are our people doing here? Our Congressional, our Governor. This is unacceptable. This has been going on for years. Ever since the deregulation of airports. So why aren't we exempt from all of these things, like Alaska? I think that's the better route, and if we do change this bill, then maybe I'll think about it. However, right now, *kako'o 'ole loa*. In strong opposition. *Mahalo*."

The motion was put to the vote by the Chair and carried, and H.B. No. 2353, SD 1, entitled: "A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION FOR SECURITY AT HONOLULU INTERNATIONAL AIRPORT," passed Final Reading by a vote of 49

ayes to 1 no, with Representative Hanohano voting no, and with Representative Cachola being excused.

Representative Luke: "Thank you, Mr. Speaker. Can all Finance members meet in the Majority Caucus Room right after session? Thank you."

Representative Takai: "Thank you, Mr. Speaker. I just wanted to announce to you and the other Members of this House, as well as our staff. Also tomorrow from 9:30 a.m. to noon in Conference Room 309, the Honolulu Police Department will be on board to answer any questions in regards to certain bills that they had introduced on behalf of law enforcement. Again, tomorrow, 9:30 a.m. to 12 noon in Conference Room 309."

Representative Hanohano: "There's also an informational briefing on our Hawaiian language immersion program by the Department of Education. It will be held tomorrow, which is Wednesday, February 19th, 2014, Room 325, 9 a.m. Department of Education, and the subject matter is the Hawaiian language immersion program and the testing results. *Mahalo.*"
