Wednesday, February 19, 2014

The invocation was delivered by Representative Jo Jordan, after which the Roll was called showing all Members present with the exception of Representative Tokioka, who was excused.

KA HUA 'ŌLELO O KA LĀ
HAWAIIAN WORD FOR THE DAY

Representative Hanohano presented *Ka Hua 'Ōlelo O Ka Lā*, the Hawaiian Word for the Day, as follows:

"Mahalo ho'omalu 'ōlelo.

Ka hua 'ōlelo o ka lā – Manuahi.

Manuahi – gratis, gratuitous, free of charge, adulterous. This word is said to have originated from the name of a Hawaiian merchant famous for giving good measure with his sales.

Keiki manuahi - illegitimate child.

Wahine manuahi - mistress, common-law wife.

Manuahi, ka hua 'ōlelo punahele 'o ka makuakane o Luna Maka'āinana Choy mai Mānoa mai kakuhew. Representative Choy's father's favorite Hawaiian word is 'free', *manuahi*.

Manuahi, 'ōia ka hua 'ōlelo o ka lā. Free, the Hawaiian word for the day. *Mahalo."*

At this time, Representative Hanohano shared *Mele Manuahi, 'Ōlelo Makuahine* with the Members of the House.

Representative Kawakami thanked the Kaiser Cougars for their sportsmanship, grace and quality of play.

Vice Speaker Mizuno honored Coach Miano and Coach Ikei and thanked them for working with him in the past.

The motion was put to vote by the Chair and carried, and H.R. No. 31 was adopted, with Representative Tokioka being excused.

At 12:46 o'clock p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:58 o'clock p.m.

REPORTS OF STANDING COMMITTEES

Representative Evans, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 556-14) recommending that H.B. No. 1678, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1678, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Cabanilla.

Representative McKelvey rose to speak in opposition to the measure, stating:

"Mr. Speaker, I just have to, regretfully at this point because of the amendments made to the measure, stand in opposition. I've discussed my concerns with the author, and I'm very happy that, because of the defective date, that she will be working with us on our concerns. But given the seismic effect that this measure has had on my community, I will be in opposition for right now and reserve further comments for Third Reading. Thank you very much."

Representative Jordan rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, please note my strong reservations at this moment and time."

Representative Har rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. Mr. Speaker, unfortunately and regrettably I will be having to go 'no' at this point. This bill would adversely affect the Ewa fields, which is back in my former district known as Kalaeloa. There's been a lot of work done on that historic property to even get it onto the national registry. Unfortunately, this current bill would have a detrimental impact upon the Ewa fields. So for those reasons, at this point, I do understand it's a work in progress, but at this point in time, unfortunately, I will be voting in opposition. Thank you."

Representative Hanohano rose to speak in opposition to the measure, stating:

"*Mahalo ho'omalu 'ōlelo.* Thank you, Mr. Speaker. *Makemake au e koho kako'o 'ole loa.* I would like to cast a strong opposition vote at this time. *'A'ohe lawa ka leo nō ka po'e o Hawai'i nei, e pili ana kēia pila. Ka pila hale 'umikumamaono kanahiku kumamawalu.* This bill, House Bill 1678, hasn't been having enough dialogue from the people of the State of Hawaii. Dialogue was only at the Legislature. Therefore, *o ko'u koho ana kako'o 'ole loa. Mahalo.*"

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Oshiro rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I need to disclose a potential conflict of interest. My understanding of this bill is that this would affect the designation of a historic property in the State of Hawaii as one as being at least 50 years or older. I currently reside in a residence that's over 50 years old," and the Chair ruled, "no conflict."

Representative Oshiro then asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Lowen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kawakami rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Carroll rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Fale rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Awana rose in support of the measure with reservations and asked that the remarks of Representative Har be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Ing rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Tsuji rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Fukumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Awana rose to respond, stating:

"Thank you, Mr. Speaker. I'd just like to include as another comment, in the committee report, it was the Historic Hawaii Foundation, the Society for Hawaiian Archeology, and a few individuals submitted testimony in opposition. So that, in the committee report, it's a red flag for me. Thank you, Mr. Speaker."

Representative Ito rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1678, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HISTORIC PRESERVATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Hanohano, Har and McKelvey voting no, and with Representative Tokioka being excused.

SUSPENSION OF RULES

On motion by Representative Cabanilla, seconded by Representative Fukumoto and carried, the rules were suspended for the purpose of considering certain a House Bill for Third Reading by consent calendar. (Representative Tokioka was excused.)

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 557-14) recommending that H.B. No. 1706, HD 1 pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1706, HD 1 pass Third Reading, seconded by Representative Cabanilla.

Representative Hanohano rose to speak in opposition to the measure, stating:

"*Mahalo ho'omalu 'ōlelo.* Thank you, Mr. Speaker. *Makemake au e koho kako'o 'ole loa.* In strong opposition. *No ka mea 'ano pu'u kālā keia pila.* The fines are too high. *O nā paikekala o ka uku li'ili'i i ke kenikeni mai.* Bikers pay a small fee. *O ke kumu no keia pilikia o ka po'e e 'a'ole e ha'i kō lākou leo.* The issue is that the people did not voice their concerns in reference to this bill. *No laila makemake au e koho kako'o 'ole loa.* Therefore, I'm still in strong opposition. *Mahalo.*"

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1706, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ILLEGAL PARKING UPON BIKEWAYS," passed Third Reading by a vote of 49 ayes to 1 no, with Representative Hanohano voting no, and with Representative Tokioka being excused.

I want to thank them for all the fine work that they have done. *Mahalo*."

Representative Ohno: "Thank you, Mr. Speaker. On behalf of the Hawaii Future Caucus, tomorrow morning we will be hosting U.S. Representative Tulsi Gabbard, who chairs the Future Caucus at the federal level. It's open to all Members, House, Senate, staff members. It's tomorrow morning at 9 a.m., in Conference Room 325. Thank you, Mr. Speaker."

Representative Fale: "Mr. Speaker, for anybody who's interested on Saturday, if they want to see some good old blood, guts and glory, we're going to have several rugby games going on over at Kapiolani Park. In which we'll be having a, I expect our team from Laie to smash anybody in front of them. So, if anyone wants to come see that. Also, we will be imuing, and if you want to sample any of the 734 pounds of Wahiawa raised pork that we caught last week Saturday that's in reserve for this, Tongan style umu going to be on. So everyone's invited to that."

Representative Belatti: "Thank you, Mr. Speaker. As everyone heads back to their communities for this much needed rest and break, I just wanted to let people know that at your tables you have a blue sheet that identifies free tax help that your constituents can take advantage of. There are clinics and sites on all islands, which the exception of Lanai. And this is a program that's put on by HACBED, as well as numerous partnering organizations throughout the community.

"In early February, urban Honolulu legislators hosted a site here where we had over 55 clients who filed their tax returns. In 2013 alone, in 46 sites statewide with over 191 volunteer tax preparers, over \$7.3 million was returned to our residents, representing over \$840,000 in fees saved. So, this is really important, and I urge you to share with your constituents as you go back to your communities this wonderful opportunity. Thank you."

Representative Lee: "Thank you. One last one, Mr. Speaker. I'd like to recognize Monday as a very important day. If for no other reason than it is the birthday of our Sergeant-at-Arms, Kevin Kuroda. Happy Birthday."
