The invocation was delivered by Representative Lauren Kealohilani Matsumoto, after which the Roll was called showing all Members present with the exception of Representatives Kawakami and Oshiro, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Seventh Day was deferred.

## ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS  
(FLOOR PRESENTATIONS)

The following resolution (H.R. No. 197) was announced by the Clerk and the following action taken:

Representative Cachola moved that H.R. No. 197 be adopted, seconded by Representative Nakashima.

Representative Cachola recognized the history and achievements of Laborer's Union Local 368 and congratulated them on their anniversary.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 911-14) recommending that H.B. No. 1638, HD 1, as amended in HD 2, pass Third Reading.

By unanimous consent, consideration of Stand. Com. Rep. No. 911-14 on H.B. No. 1638, HD 2, was deferred and in accordance with Article III, Section 15 of the Constitution of the State of Hawaii, printed copies of H.B. No. 1638, HD 2, were made available to the Members of the House.
