The House of Representatives reconvened at 12:28 o'clock p.m.

SUSPENSION OF RULES

On motion by Representative Cabanilla, seconded by Representative Fukumoto and carried, the rules were suspended for the purpose of considering certain Senate Bills for Third Reading by consent calendar. (Representatives Cachola, Carroll, Thielen and Woodson were excused.)

UNFINISHED BUSINESS

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1386-14) recommending that S.B. No. 2874, as amended in HD 1, pass Third Reading.

On motion by Representative Saiki, seconded by Representative Cabanilla and carried, the report of the Committee was adopted and S.B. No. 2874, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE BOARD OF LAND AND NATURAL RESOURCES," passed Third

Reading by a vote of 48 ayes, with Representatives Cachola, Carroll and Woodson being excused.

Representative McKelvey, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1387-14) recommending that S.B. No. 2465, SD 2, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Saiki, seconded by Representative Cabanilla and carried, the report of the Committee was adopted and S.B. No. 2465, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CONTINUING EDUCATION FOR PSYCHOLOGISTS," passed Third Reading by a vote of 48 ayes, with Representatives Cachola, Carroll and Woodson being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1388-14) recommending that S.B. No. 651, SD 2, HD 1, as amended in HD 2, pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that S.B. No. 651, SD 2, HD 2 pass Third Reading, seconded by Representative Cabanilla.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition. My previous comments on this regarding the not smoking in public housing, I think there's a myriad of problems here, and one of them is, if you go out late at night and you want to have a cigarette, you've got to go outside the building. We know that the crime in a lot of those areas is higher, and I wouldn't, even at my size, feel comfortable walking around at 11:30, 12 o'clock outside some of those buildings, number one.

"Number two, we heard mention about the complex ventilation systems. In most of these facilities it is a louver window. And so, there is no central air-conditioning or anything like that, whether it's KPT, Mayor Wright, Puuwai Momi, or all these other places. So for those reasons, I don't think it will be enforced, and I don't think it's practical. So, thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. Mr. Speaker, this is public housing. These are people who are having hard times, have been down and out or are in a transition. And, Mr. Speaker, this Body has settled many of the issues of homelessness, but I would hate to hear someone who when they were interviewed, saying, 'Why are you on the streets?' and they say, 'Well, I got caught smoking.' This bill is draconian enough to actually have these people thrown out based upon smoking in their unit.

"It's not condoning that smoking is there, but the fact that we're going to have possibly homeless people because of smoking, we've come a long way to really condemning people who maybe only have that as their only recreational effort that's left to them. So, Mr. Speaker, I think we should be circumspect about passing something this stringent. Thank you."

Representative Johanson rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Jordan rose to speak in opposition to the measure, stating:

"Mr. Speaker, please note my opposition. Mr. Speaker, I think we should always allow the department to continue with their rulemaking process, and I don't think the Legislature should step in front of that process until it is exhausted. My understanding, the department has been working on their rules, they haven't completed them. We have to be cognizant of these individuals that live in our public housing.

"I understand people don't want to inhale smoke if they're non-smokers. I'm a child of a smoker, and I grew up around that. So I could be subject to secondhand smoke at any point in time through my life. So I understand

individuals that live in our public housing, and their major concerns. And I have those concerns. But until such time we can honor their concerns, as well as individuals that may have an addiction to smoking and can't use any alternative devices, how do we still help them with public housing when there's no other alternative for them? I haven't heard that from my authorities.

"So this I think is going before we can address some of these issues. And we all know in this place that we have an issue with public housing. We don't have enough. We don't have enough private housing out there for low-income individuals. So until such time we get further information and answers on how we can address this more cohesively, I don't think we should be moving with a measure that is 'upon approval' at this point in time. Thank you very much, Mr. Speaker."

Representative Cabanilla rose to speak in support of the measure, stating:

"In support, Mr. Speaker. I just would like to make the comment that as a former Chair for the Committee on Housing, we did pass a resolution asking the department, or the Housing Authority, to come up with this rulemaking, maybe five, six years ago. And up to this day, they have not come out with that rulemaking."

Representative Creagan rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I rise with reservations. My problem is partly with the inclusion of electronic smoking devices. Recent studies have shown that devices that vaporize nicotine, without smoke, but just vaporize nicotine, which might be included under the definition of electronic smoking devices, actually help decrease the symptoms of Parkinsonism and might be a medical device that could be used to treat Parkinsonism. So therefore you're excluding people treating their Parkinsonism because you're excluding electronic smoking devices. Thank you, Mr. Speaker."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. May I please have the words of the Representative from Waianae entered into the Journal as if they were my own? And very quickly, my issue with this bill really stems from the portion which authorizes termination of the lease, rental agreement, permit or license, and the eviction of a tenant for violation of the smoking prohibition.

"As noted by the Representative from Hawaii Kai, these are draconian measures. These are people who are in public housing. And so, yes, nobody is condoning smoking. We all know the secondhand effects, but the HD 1 had very different, there was at least a 'four strikes, you're out' provision. This is much more draconian. And for those reasons, Mr. Speaker, what are we going to do, we're just going to kick people in public housing out on the street and then increase homelessness?

"That is not what we should be doing in this Body. We should be looking out for these people. And we should be trying to look at a holistic, systemic approach to dealing with their smoking issues, as opposed to simply kicking them out on the street for violating the smoking prohibition. So for those reasons, Mr. Speaker, respectfully, I must vote in opposition. Thank you."

Representative Fale rose in opposition to the measure and asked that the remarks of Representative Har be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I would just point out a couple of things that have been raised and I believe are incorrect. First of all, the HPHA does not oppose this bill. They're willing to see it go forward, and they don't

believe that it's in conflict with the rulemaking process that they're undergoing already.

"I think the other thing that would be very unfortunate is if someone who was particularly susceptible to secondhand smoke, other than the fact that it's a known class 1 carcinogen, but someone who, for example, was asthmatic. If they were forced onto the street because their next door neighbor smoked and they couldn't get away from the smoke and they had nowhere else to live because of their income level. So I think you have to look at it from both sides there.

"Finally, with regard to the e-cigarette part of it, the last version of the bill, I do not see any language that refers to e-smoking at all. It only refers to smoking. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Oshiro rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm glad that you're encouraging us to discuss this issue before us today. I'd like the words of the Representatives from Hawaii Kai, Waianae, and Kapolei entered into the Journal as if they were my very own. Thank you, Mr. Speaker.

"I also have an additional comment when I look at this measure. My understanding is that the Hawaii Public Housing Authority was already well underway to promulgate rules regarding smoking in public housing units and to also deal with those who might be addicted to nicotine. As we all know, nicotine is a bona fide addiction that needs to be treated for the addicted person to get relief. So I thought they were on their way to promulgate some rules. In fact, I think, according to the Hawaii Public Housing Authority's executive director, they were already going to public hearings to promulgate rules.

"So, this seems to be unnecessary at best and draconian at worst. Let me explain to you why I think this is horribly draconian. It states that effective July 1, 2014, the authority will be prohibited from entering into any lease, whether it's a rental agreement, permit, license, or even a month-to-month tenancy, Mr. Speaker.

"Here we are in April. That means in a matter of, May, June, July going forward, three months going forward, none of these tenants currently in our public housing system will be allowed to smoke within their residences. I don't know how many of them have bona fide tobacco addictions, are addicted to cigarettes or nicotine, but I think it's going to really put a burden upon these individuals, as the law would then compel them to prohibit that within their units.

"I also have concerns about being held liable, Mr. Speaker. Almost in the strict liability sense of one's guest, and I understand that's the current rules right now, in application right now. But if a guest should innocently or inadvertently light up or use some kind of tobacco device unbeknownst to the tenant of the Hawaii Public Housing Authority, he or she might then be summarily evicted."

At 12:40 o'clock p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:40 o'clock p.m.

Representative Oshiro continued, stating:

"Mr. Speaker, I am against this bill. I am opposed to this bill. You might have assumed otherwise, but anyway let me just finish up. I think it's unnecessary at best. I think it's draconian. July 1 is right around the corner, Mr. Speaker. Can you imagine any month-to-month tenancy going forward? You can't have that. You can't allow that. That's prohibited going forward. I think that's a bit extreme, especially since they're trying to deal with it right now.

"For those reasons, Mr. Speaker, I will be opposing this measure. Thank you very much."

Representative Tokioka rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With very strong reservations. Mr. Speaker, I think it's important for me to note that I was one of three council members 15 years ago that put together a ban and a bill that banned smoking in restaurants, along with the Maui County and Oahu County. So I do not support smoking, but I do know that people that smoke have very few options, and sometimes the places that they need to go to smoke are out in the rain.

"I do know that the Representative from North Kauai and I get texts and emails from a constituent of ours that lives in public housing now, and her neighbors are doing drugs. And they cannot even enforce that. How are they going to enforce this? So for all of those things, I'm with very strong reservations with this bill, Mr. Speaker. Can I ask that the words of the Representatives from Kapolei, Wahiawa, Waianae, and Kahala be inserted as if they were my own? Thank you, Mr. Speaker," and the Chair "so ordered." (By reference only.)

Representative Thielen rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Mr. Speaker, I'm rising in support of the measure. Mr. Speaker, our communities have changed very much from the days when my oldest son was a youngster. When he was growing up, and some of you that are old enough in this Body will remember, smoking was everywhere, absolutely everywhere. Dave never smoked, but he developed secondhand smoke cancer, throat cancer, and almost died from it. So I am firmly in support of measures that will let people have clean air to breathe. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, second time, but I'd like to rebut the Majority Floor Leader and some of her comments about the lack of rulemaking and that gives us the divine right to micromanage the situation.

"In Singapore, if you spit on the sidewalk, you're going to get a \$50 fine. If you smoke in a taxi, \$50 fine. If you don't flush a toilet, \$50 fine. We are not Singapore, Mr. Speaker. We're a democracy, and contrary to what my friend from Kailua said, we're not talking about being against guarding the safety and the health of people. We're talking about the draconian measure that, if you smoke, you get thrown out on the street. Mr. Speaker, that is Singaporean, that is draconian.

"There's no excuse for us, when we plead and we cry about the homeless situation, and we don't give money, and we give our sympathy, and then we turn around and pass something like this for people who are already down and out. Mr. Speaker, where is the heart? Where is the *aloha*? Are we putting really our heart where these policies are sending?

"I just think it's hypocritical, and we should be circumspect, again, about passing something like this, that even though they agreed to it, it's something that we shouldn't be micromanaging at the level of their tenancies. We've got 12,000 homeless people, we're going to add more by doing this starting in July 1. Thank you."

Representative Kawakami rose in support of the measure with reservations and asked that the remarks of Representatives Har and Oshiro be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Awana rose in support of the measure with reservations and asked that the remarks of Representatives McDermott, Ward, Jordan, Har, Oshiro and Tokioka be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Tsuji rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Say rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Brower rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Soon, you won't be able to smoke in parks anyway. So if you're homeless in a park, you won't be able to smoke there. A lot of us supported no smoking in parks and in beaches, and Members, where did you think this was going? This is the natural conclusion on where this bill is going. And I think it's picking up steam like a snowball rolling downhill. If we're not going to allow smoking in parks, why would we allow it in government funded housing? Thank you."

Representative Ing rose to speak in support of the measure, stating:

"Mr. Speaker, standing in support. I just wanted to note that the Department of Health testified in support of the measure and they do want the provision in statute. I also wanted to make a point that this bill puts public housing with, it creates a parity with private buildings, businesses that serve a public purpose, which already you're not allowed to smoke in.

"Lastly, the enforcement issue, I don't think that most smokers are law breakers. Those people that are doing drugs are already criminals, and they might break the law. But I think most smokers are law abiding citizens and they'll follow the rules. And 92 percent of smokers want to quit, and if they don't have a lot of money to spend, this is a great habit to drop, and maybe this will give them some incentive to do so. Thank you."

Representative Saiki rose to speak in support of the measure, stating:

"Mr. Speaker, just two brief comments in support of this measure. First, I just wanted to note that this legislation actually reflects the growing trend that you find in high-rise condominiums where associations are beginning to enact no smoking bans in high-rise buildings.

"The second point is that this legislation will not result in the summary eviction of residents who smoke in public housing, because this legislation actually gives the Housing Authority the flexibility to enforce such a provision. Also as we are aware, as we know, the Housing Authority is required to follow a very formal due process requirement when it comes to evicting or attempting to evict a resident. So that process would have to be exhausted before a decision is made whether or not to evict a resident for violating this statute. Thank you very much."

Representative Hashem rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Hashem's written remarks are as follows:

"I stand in strong support of SB 651 which will prohibit smoking in public housing units and set up nearby designated areas where smoking will be permitted. Public housing should provide healthy living conditions for all tenants. Those tenants in public housing who do not smoke prefer reasonable protections from those who do.

"I believe prohibiting smoking in units and alternatively providing nearby designated smoking areas offers the best way to bring effective compliance and enforcement. Smoking provisions also will be part of new rental agreements, and tenant failure to comply can result in termination of the rental agreement and eviction.

"Passage of this bill will make public housing a much healthier and more desirable place to live."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 651, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Third Reading by a vote of 42 ayes to 6 noes, with Representatives Fale, Hanohano, Har, Jordan, McDermott and Oshiro voting no, and with Representatives Cachola, Carroll and Woodson being excused.

JOINT HOUSE-SENATE
2014 COMMITTEES ON CONFERENCE PROCEDURES**

The Senate and the House have agreed to the following special procedures for all 2014 Regular Session Committees on Conference. These Conference procedures shall be effective from 8:00 a.m. on April 14, 2014 until 12:00 midnight on April 25, 2014.

1. Definitions

For purposes of these procedures:

"Chairs" refers to all of the designated chairs and co-chairs of a Conference Committee.

"Conference Committee" refers to the conference of the House Committee and the Senate Committee assigned by their respective chamber to resolve the differences between the House and the Senate over a particular measure.

"Lead chair" refers to the chair of the House Committee or the Senate Committee who is listed first on the Action Sheets, as provided by the respective chamber.

"Lead committee staff" refers to the staff of the lead Chair from the chamber from which the measure in conference originated.

"Managers" refers to all members of the House and Senate assigned to a Conference Committee.

2. Conference Committee Scope and Amendments

The authority of the Conference Committee shall be limited to resolving differences between the Senate and House drafts of a measure. Accordingly:

- a. With the exception of the Executive Budget, the Judiciary Budget, and the Budget of the Office of Hawaiian Affairs, a Conference Committee shall not amend a measure by inserting any unrelated or new subject matter.
- b. To assure the integrity of individual measures, the merging of two or more distinct but related measures into one encompassing measure shall not be allowed.

3. Conference Committee Meeting Times and Places

Conference Committee deliberations shall take place only between the hours of 8:00 a.m. and 12:00 midnight.

A Conference Committee shall meet in the conference room assigned or reserved, pursuant to the Room Scheduling Procedures and Guidelines and Room Assignment Schedule, as attached.

4. Initial Public-Meeting Notice

The signatures of all chairs shall be obtained before the notice of an initial meeting is posted or distributed. Prior to offering the initial meeting notice for signatures, the chairs shall consult with one another on the information to be included in the notice. Lead chairs from both houses are encouraged to sign meeting notices first, before distributing them to other chairs to sign.

Chairs shall provide at least 24 hours public notice of the first meeting of the Conference Committee and are strongly encouraged to provide more than 24 hours notice if at all possible. Written notices shall be submitted to the Senate Chief Clerk and the House Sergeant-at-Arms for official postings on the Legislature's website and Capitol bulletin boards. The lead committee staff shall post the notice adjacent to the door of the assigned conference room at the time of the meeting.

5. Notice of Subsequent Meetings

- a. If agreement is not reached at a duly noticed meeting but the lead chairs of both chambers agree to meet again before midnight on the same day, the lead chairs of both chambers shall publicly announce at the meeting the time and place at which the

Conference Committee will reconvene. Written notice of the reconvening of the Conference Committee on the same day is not required to be distributed. However, written notice containing information on the subsequent meeting shall be submitted to the Senate Chief Clerk and the House Sergeant-at-Arms for official posting as soon as possible. The lead committee staff shall post the notice adjacent to the door of the assigned conference room at the time of the meeting.

- b. If agreement is not reached at a duly noticed meeting but the lead chairs of both chambers agree to meet on another day, the lead chairs of both chambers shall publicly announce at the meeting the date(s), time(s), and place of the subsequent meeting(s), and submit written notice to the Senate Chief Clerk and the House Sergeant-at-Arms for official posting. The lead committee staff shall post the notice adjacent to the door of the assigned conference room at the time of the meeting.
- c. If agreement is not reached at a duly noticed meeting and the date(s), time(s), and place of future meetings are not publicly announced at that noticed meeting, chairs shall ensure that a written meeting notice, signed by the lead chairs of their respective chamber, is submitted to the Senate Chief Clerk and the House Sergeant-at-Arms for official posting at least 24 hours in advance of the next meeting of the Conference Committee.

6. Attendance at Meetings

- a. To convene the initial conference committee meeting only the lead House and Senate chair must be present. All other conference committee managers, especially any co-chair, should attempt to be present.

- b. Once a conference has been opened, reconvening of any subsequent meeting of a conference committee shall require the following:

For the Senate, the lead chair or co-chair must be present.

For the House, the lead chair must be present.

All other conference committee managers, especially any co-chair, should attempt to be present at the convening of and during each meeting.

- c. For decision-making at a meeting, a quorum must be present. "A quorum shall be a majority of the House Committee managers and a majority of the Senate Committee managers, and shall include the lead House and Senate chair and majority of the chairs of the Conference Committee for their respective chamber." See Section 9.a of the "Procedures." The lead House and Senate chair of the conference committee must be part of this quorum.
- d. For a measure with fiscal implications, approval must be given by the chair representing the House Finance Committee and Senate Ways and Means Committee during the decision-making on the measure.

7. Conference Discussion

Except as authorized by the respective chairs, only the respective chairs may speak during conference. All other managers or other authorized persons shall be recognized by their respective chairs before speaking on any issue.

8. Decorum in Conference Committee Meetings and Courtesy to the Public and to the Managers

- a. Managers shall respect the differing views of other managers and conduct themselves in a courteous manner.
- b. Chairs shall ensure that meetings convene and reconvene at scheduled times. If none of the chairs of one of the Committees are present within 15 minutes of the scheduled meeting time, the chairs of the other Committee shall have the names of the absent chairs paged through the State Capitol public address system.

Conference Committee Room Scheduling
Procedures and Guidelines**

Effective beginning at 8:00 a.m. on April 14, 2014 through 12:00 midnight on April 25, 2014, the following scheduling procedures and guidelines shall apply for all House and Senate conference rooms.

Priority for use of the conference rooms will be given in the following order:

- 1st Priority: Standing Committee Bill Hearings
- 2nd Priority: Conference Committee Meetings
- 3rd Priority: Committee Hearings for Resolution and Governor's Messages

Please note the following procedures and guidelines for the use of rooms for conference purposes:

1. If your committee is designated to use one of the House conference rooms (i.e., rooms 309, 312, 325, 329 or 423), please contact Rodney Haena of the House Sergeant-at-Arms office at 586-6104 to reserve the room.
2. If your committee is designated to use one of the Senate conference rooms (i.e., rooms 016, 224, 225 or 229), please contact Linda Kahana of the Senate Sergeant-at-Arms office at 586-6725.
3. Committees assigned to a specific conference room will be given first priority in using that particular room for conference committee meetings.
4. Committees shall not allocate the use of its assigned room to another committee. All room assignments must be coordinated through and made by either the House Sergeant-at-Arms or Senate Sergeant-at-Arms.
5. For those committees that must share assigned conference rooms, it is strongly recommended that you meet as soon as possible with other committee chairs who are also assigned to that room to formulate a basic timetable for sharing the room.
6. In consideration of the other committee chairs, do not reserve a block of specific times unless a timetable has been agreed to.
7. If you have reserved a particular time slot that subsequently you will not be using, please notify either the House Sergeant-at-Arms or Senate Sergeant-at-Arms as soon as possible so that those room times can be assigned to someone else if needed.
8. If your conference committee needs to meet, but your assigned room is reserved or in use by one of the other committees also assigned to that room, please contact either the House Sergeant-at-Arms or Senate Sergeant-at-Arms to locate a vacant conference room for your temporary use.
9. Conference committees are encouraged to give as much advanced notice of meetings as possible. However, since things do get very hectic during conference, please be aware that any lower priority room requests may be "bumped" or reassigned with only a short notice. Hopefully, these inconveniences will be kept to a minimum.
10. Exception to these House-Senate Conference Committee Room Scheduling Procedures and Guidelines may only be made with the joint approval of President Donna Mercado Kim and Speaker Joseph M. Souki.
