Your Committee on Health, to which was referred H.R. No. 62
entitled:

"HOUSE RESOLUTION ENCOURAGING FOOD SERVICE FACILITIES IN THE
STATE THAT OFFER A CHILDREN'S MENU OF MEAL OPTIONS, OR A MEAL
THAT IS REPRESENTED AS A CHILDREN'S MEAL, TO SERVE CHILDREN'S
MEALS WITH HIGHER NUTRITIONAL QUALITY AND INCLUDE ONLY
BOTTLED WATER OR LOW-FAT MILK AS THE DEFAULT BEVERAGE IN THE
MEAL OR MENU OPTION,"

begs leave to report as follows:

The purpose of this measure is to encourage all food service
facilities in the State that offer a children's menu of meal
options, or a meal that is represented as a children's meal, to
serve children's meals with higher nutritional quality and include
only bottled water or low-fat milk as the default beverage
included in the meal or menu option.

The Hawaii Pacific Health Institute, American Heart
Association, and an individual testified in support of this
measure.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee concurs with the intent and purpose of H.R. No. 62 and
recommends that it be referred to the Committee on Economic
Development & Business.
