## TWENTY-THIRD DAY

Thursday, March 5, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 12:05 o'clock p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Chris Lee, after which the Roll was called showing all Members present with the exception of Representatives Kawakami, LoPresti, Say and Souki, who were excused.

"Mr. Speaker, no vote, and as a courtesy to the Members, I will not bloviate today. Thank you."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition. Also not bloviating, but to make it very clear that this is a middle class bill killer. This is a middle class bill killer. And because it's a tax increase that is so confounding and confusing, it's based upon a percentage rather than it used to be a barrel. This is going to be a complication, because you know how volatile fuel prices are. They are every day changing, as you can see now your neighborhood pump goes up a little bit every day.

"So for those reasons, I think we're going to try to gain a few pennies out of this, but I think in the end we're going to lose because it's going to cost so much money to rejigger the hardware for DOTAX or any other organization to implement it. Thank you, Mr. Speaker."

Representative Fukumoto Chang rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Tupola rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kawakami rose to disclose a potential conflict of interest, stating:

"May I ask for a ruling on a potential conflict? I work for a company that sells fuel," and the Chair ruled, "no conflict."

Representative Kawakami continued, stating:

"Can we have this apply for the rest of the session?"

The Chair addressed Representative Kawakami, stating:

"Yes."

Representative Kawakami continued and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in opposition to House Bill 1486. This bill proposes that the state fuel tax rate be an unspecified percentage of the wholesale price of a gallon of fuel, or 17 cents per gallon, whichever is greater. As you may know, the price of oil and the wholesale price of fuel fluctuate on a daily basis. The global economy, and supply and demand ultimately determine how much a Hawaii consumer pays for their gasoline.

"It is unfair to place the burden of this new fuel tax scheme on my constituents who rely on their automobiles to travel to and from work

every day. They, along with our neighbor island residents, are the ones that will be most affected by this proposal. Furthermore, this bill places a burden on our small businesses, gas station owners and franchisees that will have to continuously recalculate the fuel tax rate on a daily basis and subsequently remit payment to the Department of Taxation.

"The Department of Taxation testified that 'while the Department appreciates the desire to adjust the fuel tax rate to the cost of fuel, the Department suggests a simple adjustment to the rate.' 'The adjustment provided in this bill will create confusion for taxpayers and administrative challenges both in ensuring compliance and in educating taxpayers regarding the change in the law.'

"Mr. Speaker, I fear that this bill will allow the price of gasoline to rise, not if, but when the price of oil rises again. I understand that the intent of this measure is to make the state fuel tax a viable source of revenue for the State Highway Fund. However, we must utilize existing sources of revenue to fund the highway fund rather than increase the burden on Hawaii's taxpayers.

"Hawaii residents already pay the second highest rate in the nation for their gasoline and the highest rate for their diesel. These exorbitant rates are further compounded by the federal fuel tax, the state fuel tax, the county fuel tax, the GET and the barrel tax.

"Therefore, until a more equitable and efficient method to increase revenue for the State Highway Fund is proposed, I must respectfully vote in opposition to House Bill 1486."

Representative Pouha rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative LoPresti rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Cachola rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1486, entitled: "A BILL FOR AN ACT RELATING TO THE STATE FUEL TAX," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cachola, DeCoite, Kawakami, LoPresti, Thielen, Tokioka and Yamane voting aye with reservations, with Representatives Cullen, Fukumoto Chang, Har, Matsumoto, McDermott, Pouha, Tupola and Ward voting no, and with Representatives Say and Souki being excused.

Thank you."

Representative LoPresti rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in strong support of HB 561. In the current age of technological innovation, this bill aims to protect employees and potential employers from unreasonable requirements from employees to share private and personal credentials for online accounts.

"While the intent of the bill is not to dictate to employers on their management practices, it is imperative for the State of Hawaii to safeguard the civil rights of our state's employees from unauthorized access. Employees should have the same rights to privacy online as they do offline. I urge my colleagues to support this bill. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 561, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SOCIAL MEDIA," passed Third Reading by a vote of 49 ayes, with Representatives Say and Souki being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 618) recommending that H.B. No. 385, HD 1 pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 385, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Keohokalole rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kawakami rose to disclose a potential conflict of interest, stating:

"Thank you. I'd like to ask for a ruling on a potential conflict of interest. The company I work for sells tobacco products," and the Chair ruled, "no conflict."

Representative Kawakami continued to speak in support of the measure with reservations, stating:

"Strong reservations."

Representative Oshiro rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Oshiro's written remarks are as follows:

"Mr. Speaker, I rise in support of HB 385, HD1, but with reservations.

"Let me preface my remarks by stating that I stand by my record on tobacco and nicotine. I truly believe that cigarettes and tobacco-related products are a plague on our citizens and all efforts should be made to rid our communities of these substances, or at a minimum, limit their

availability and use. Especially, the ease at which so many minors have easy access. As we all know, under present law in Hawaii, you are deemed an adult at age 18, and can legally purchase tobacco products.

"The fact is, I introduced two bills this year to do just that – one to place nicotine on Schedule V under the Controlled Substances Act (House Bill No. 331) thereby placing it under the jurisdiction of the Narcotics Enforcement Division subject to the same and similar regulation of some medicines; the other to impose the General Excise Tax on all products containing nicotine at the rate of 10% at both the wholesale and retail levels (House Bill No. 748). This was to raise the assessment of tax policy that affects and influences consumer behavior but also to generate a frank discussion on our 'love and hate' relationship for tobacco; we love it for the money it raises, but we hate it for the premature death it causes. Both failed to receive a public hearing, but I hope that your Chair on Health will consider them for next year.

"My reservations stem from the irony that House Bill No. 385 generates. First, it would raise the age that a person may purchase any tobacco product or electronic smoking device from 18 to 21 – tobacco being a product that is legal to consume under both federal and State law and subject to strict regulation under the food and drug administration. Yet, currently for medical marijuana, a substance that is illegal under both federal and State law, the State provides limited immunity for any registered patient to consume, regardless of age.

"In other words, if House Bill No. 385 is approved, it would be against the law for a person 20 years of age to purchase a pack of cigarettes. Yet, a child half that age could smoke a joint of medical marijuana if the child's legal guardian is duly registered and compliant with Hawaii's Medical Marijuana Law.

"Similarly, if this bill is approved, it would be against the law for a person under the age of 21 to buy or smoke a cigarette, but a person older than 18 could buy and smoke a marijuana-cigarette, subject to the restrictions under our Medical Marijuana Laws. And, this is the same citizen we legally consider an adult, with all the privileges and liabilities of obtaining that age. At 18, a person can get married or command an army platoon, or run for a seat in the State House of Representatives. But, if House Bill No. 385, House Draft 1 becomes law, the same person would not be able to buy cigarettes or an electronic smoking device.

"It just seems so surreal... and frankly, ridiculous, don't you think? My Wahiawa friends would say, 'What are they smoking?'

"For these reasons, while I support House Bill No. 385, House Draft 1, for its obvious public health benefits, if we are going to base our decisions on science and facts, let's do so across the board and not merely on issues that embrace the lowest denominator. These kinds of bills are 'sexy' and make headlines, but in doing so, elevate the arguable health benefits of similar practices, while grossly dismissing the known physical and mental health dangers of the same.

"I hope my colleagues will take these words under consideration – let's not create mixed messages in our laws. As always, I stand ready and remain available to assist in further refinement of the underlying policy. Thank you, Mr. Speaker."

Representative Johanson rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations, and I note the irony that I am a primary introducer of the bill, but what the heck."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 385, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Third Reading by a vote of 47 ayes to 2 noes, with Representatives DeCoite, Har, Johanson, Jordan, Kawakami, Keohokalole, McKelvey, Oshiro, Tokioka and Ward voting aye with reservations, with Representatives McDermott and Ohno voting no, and with Representatives Say and Souki being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 619) recommending that H.B. No. 525, HD 2 pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 525, HD 2 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Morikawa rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Reservations and just a quick comment. I think the department would be tasked in signage in areas that they can have smoking, but I think it's better if the department be allowed to designate a whole park that's prohibited from smoking. I think that would be a better resource for the department. Thank you."

Representative Kawakami rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Tupola rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations, brief comment. Mr. Speaker, this bill is well intended, but it leaves a loophole where it mentions smoking but it doesn't mention THC or marijuana, except I guess if you're putting it in one of those electronic, if you put marijuana in the electronic one it would be okay. So it looks like that, the way it's defined, is a bit of a loophole to where you can't smoke in a park, you can't use the e-cigarette, but if you put marijuana into an e-cigarette, you can do it. At least that's the way I'm reading it right now. Thank you, Mr. Speaker."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Oshiro rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, reservations. My concern primarily arises from the final definition of what is considered state parks. On my side of the island we have a lot of state park land, unimproved lands that people access for fishing, recreational purposes. That's my concern. Thank you."

Representative San Buenaventura rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Pouha rose in support of the measure with reservations and asked that the remarks of Representative Oshiro be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B.
