FORTIETH DAY

Thursday, April 2, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 12:13 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Mr. Tuia'ana Scanlan, after which the Roll was called showing all Members present with the exception of Representative Kong, who was excused.

On motion by Representative Evans, seconded by Representative Tupola and carried, reading of the Journal was dispensed with and the Journals of the Twentieth, Twenty-First, Twenty-Second and Twenty-Third Days were approved. (Representative Kong was excused.)

SENATE COMMUNICATIONS

No. 48, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING THE DIVISION OF AQUATIC RESOURCES AND DIVISION OF CONSERVATION AND RESOURCES ENFORCEMENT TO COLLABORATE WITH FEDERAL PARTNER AGENCIES TO PROTECT IMPORTANT STATE MARINE RESOURCES," which was adopted by the Senate on April 1, 2015.

Sen. Com. No. 384, transmitting S.C.R. No. 158, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO EXAMINE IF AND HOW OTHER STATES REGULATE TOUR OPERATORS WITHIN THEIR JURISDICTION," which was adopted by the Senate on April 1, 2015.
