



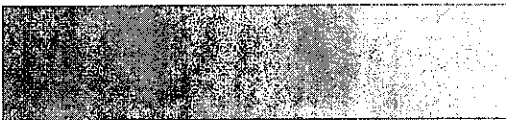

## TWENTY-SEVENTH DAY

Friday, March 13, 2015
