## Duties

- Prepares the operating budget for Suburban Field Services. Project costs for future operational needs and for anticipated special projects. Analyze current and past fiscal data of the section in an effort to be fiscally efficient and to improve operations.
- Reviews and analyze construction plans for the water distribution system and facility renovations. Provide feedback for revisions and recommendations in the design.

- Work with subordinate supervisors on comprehensive plans for all section activities including the distribution of water during emergency water outages.
- Establish and oversees the in-service training for employee development, regulatory requirements, and to improve the activities of the section.
- Responsible for the investigation and resolution of customer complaints and employee grievances. Prepares letters, inquiries, and responses to complaints received by the Division for the Program Administrator.
- Conducts monthly communications meetings with the section to disseminate information from the Field Operations staff meetings, safety meetings, and address the concerns of the section.
