Anderson's character, honesty and work ethic as well as his experience in law enforcement, private security and as a business owner qualifies him as an excellent choice for the Commission.



I am much honored to be nominated by Governor David Y. Ige to the Corrections Population Management Commission. As a business owner and retired Police Officer, I recognize the need to carefully manage the corrections population to ensure that the State Correctional facilities are not too overcrowded while still ensuring the safety of the community.

My background is in law enforcement, safety and security. In 2002 I retired from the Honolulu Police Department at a Lieutenant with over 26 years of service. I then went to work for the State Attorney General's Office as a Special Agent. While there, I organized the "Cold Case Unit", which was tasked to investigate unsolved murders statewide. I assisted in obtaining the Federal grant to pay for the unit and formulated policies and procedures for the unit to operate.

In May of 2005 I was hired into the private sector at Star Protection Agency, the largest locally owned security firm in the State. I currently own Star in Hawaii and we offer security and investigative services for clients requesting our services. Included in this, are some investigative services for Attorneys defending their client's actions in criminal courts. In 2007 I was board certified in security management by ASIS International as a "Certified Protection Professional" (CPP).

Since being in the private sector, I have learned that we certainly cannot keep all inmates incarcerated for the life of their sentence. We must find that fine line to integrate them back into society while ensuring the safety of our community. I hope to contribute my knowledge and experience in dealing with both the private sector and law enforcement to provide the Commission with valuable input in the population management of the State facilities. I do not foresee and conflicts of interest, but should any arise I will recuse myself from any decisions in those matters.
