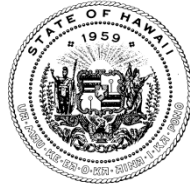

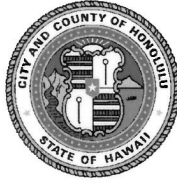
The DOT respectfully requests that this Committee confirm John Goody to the State Highway Safety Council.
