Hovsep Kazazian, Member of the First Ottoman Parliament 1877-1878, representing the province of Diyarbakir. This elected body was disbanded by the Sultan after two years. He was on excellent terms with the central government until shortly before he was brutally killed in his old age during the Genocide of 1915. He was a manufacturer of silver and copper tableware, had thousands of acres in foodstuff cultivation and owned a mining operation. His wife, Sophie and many members of his extended family perished when they were marched into the desert without food or water.

Senate Concurrent Resolution No. 73

Declaring April 24 as a day of remembrance in recognition and commemoration of the Armenian Genocide of 1915.

I Strongly SUPPORT this resolution. Thank you for hearing this resolution and giving me the opportunity to speak up for those who cannot speak for themselves.

2015 is the centennial of the world's first genocide. One hundred years ago from 1915 through 1923, the Ottoman Empire - covering what is now Turkey, Iraq, Syria, Iran, Jordan, and Israel- conducted a systematic campaign of ethnic cleansing against one group, Armenians. Approximately, 1,500,000 men, women, and children were killed, another 500,000 were forcibly re-located from their nation, homeland, and communities. Each year on this day, April 24, Armenians honor those who perished in first genocide. There are 33 countries, including 30 states, who have memorials for these Armenian victims of genocide.

In 2007 State of Hawaii took a stand against genocide by adopting an ERS divestment law to remove our support from the Sudan Government committing genocide against southern Sudan. This effort joined others who helped to establish the new independent nation of South Sudan. In 2009, the House did their part for Armenia by declaring their recognition of Armenian Genocide. But the Senate has yet to do their part.

Remembering genocide today is of vital importance. As recently as September 21, 2014, the Islamic State of Iraq and al Sham (ISIS) destroyed the Armenian Holy Martyrs Church in Der Zor, Syria. The church and museum was constructed in memory of the victims of the 1915 Armenian Genocide suffered at the hands of these predecessors to ISIS, the Ottoman Empire. ISIS wants to complete the genocide by purging our memorials to its victims.

The United States Holocaust Memorial Museum in Washington, DC has displayed this poem, entitled: "First they came..." by Pastor [Martin Niemöller](#) (1892-1984) about the cowardice of German [intellectuals](#) following the [Nazis'](#) rise to power and the subsequent [purging](#) of their chosen targets, group after group.

**First they came for the Socialists, and I did not speak out—
Because I was not a Socialist.**

**Then they came for the Trade Unionists, and I did not speak out—
Because I was not a Trade Unionist.**

**Then they came for the Jews, and I did not speak out—
Because I was not a Jew.**

Then they came for me—and there was no one left to speak for me.

We must speak out now. Thank you.

of state. Congressman Sherman said " It is time for both the executive branch and the legislative branch to do the same,".

House Democrat Adam Schiff, a lead sponsor of the bill, said it was "indisputable" that Armenians "were deliberately murdered in the first genocide of the 20th Century."

"Denial of the Armenian Genocide undermines foundations for durable peace and security, making future atrocities more likely," added Republican Robert Dold.

He said Washington must send a message it will not tolerate "any country that hides behind bully tactics to shroud violations of human rights."

House Democrat Jackie Speier, who is Armenian-American, described to reporters how Armenians were "death-marched" from their villages in large numbers.

"It's history now, but it's time for us to recognize it once and for all," Speier said.

Over the years the slaughter has been recognized in the United States in various ways.

President Ronald Reagan branded it a genocide in a 1981 proclamation, and more than 40 individual US states have taken similar action.

The House Foreign Affairs Committee recognized the Armenian "genocide" in 2010, triggering fury in Turkey, a key majority-Muslim ally of Washington.

House Speaker John Boehner has not indicated whether he will bring the latest measure to the floor, and the White House declined to comment on it.

Around 20 nations, including France and Germany, recognize the killings as genocide.
