I. Background and Summary

The Hawaii Agricultural Foundation (HAF) is a non-profit charitable organization created to promote agriculture and farming. Created in 2007 (initially as *The Hawaii Farm Bureau Foundation for Agriculture*, and renamed *The Hawaii Agricultural Foundation* in 2010), the mission of HAF is to support and sustain Hawaii's agricultural industry by addressing critical needs and services of farmers and the agricultural industry in Hawaii, and by better connecting the farmers with the community and vice-versa. This involves educational and outreach programs in the community, as well as direct marketing, technical, educational and in-the-field support for farmers.
2. The goals and objectives related to the request:

The goal of the HAF's Ag Education Expansion Program: Creating Partnerships to Develop the Best Possible Agriculture and Natural Resources Education for Students supports the State's goal to local agricultural as a strategic public investment to build community resilience and strengthen the productive economic base. Furthermore, the grant supports the *Increased Food Security and Food Self-Sufficiency Strategy Plan* that was prepared by DBEDT Planning and DOA that identified that we need to build the agricultural workforce and continue the "Green Jobs Initiative" which provides workforce development services for the agricultural, energy, natural resources and related industries in order to increase food production.

The HAF Ag Education Expansion Program: Creating Partnerships to Develop the Best Possible Agriculture and Natural Resources Education for Students will:

- (1) foster stronger relationships between organizations that promote sustainability within our food systems;
- (2) utilizing existing resources to maximize efficiencies;
- (3) build capacity and leadership in agriculture and natural resource teachers;
- (4) develop more effective partnerships between industry and academia partnerships with industry;
- (5) create an ongoing forum for dialogue and meaningful discussion featuring food sustainability as a primary theme and addressing the ever changing landscape of agriculture and natural resource management in

Hawaii.

3. The public purpose and need to be served;
With the recent closure of HC&S, the State of Hawaii has more than 36,000 acres available for sustainable and diversified agriculture. The closure will, no doubt, have a major effect on Maui's economy and how the State and A&B proceeds in the transition from sugar toward diversified agriculture is critical to the future of agriculture in our state.

Alexander & Baldwin (parent company to HC&S) has plans for the sugar lands to remain in agriculture. Food crops, energy crops and ranching are among some of the initial initiatives proposed. With Hawaii importing 85% of all the food it needs for consumption, the most compelling use of that land is for food crops. However, based on past history of other plantation closures the success of transition to food crops and diversified agriculture will be a challenge. Part of the plan is for A&B to develop an agricultural park where several independent farmers can farm. However, A&B also acknowledges that farming is a scientific and business enterprise and their current workforce may not be able to transition to these new jobs because they don't have the skill set to be independent farmers.

At the same time, there are many other critical issues facing agriculture and Hawaii's food supply including the closure of Hamakua Springs (Richard Ha, one of the most premiere farmers in our state recently closed his farm), the challenges of our fisheries and new shore fisherman, the difficulties faced in ranching and the misinformation in the public on many of these issues.

As part of this grant, HAF will also initiate a public educational program that will address the need for better information and communication with the community on agriculture and natural resource issues. Over the last few years, the community has been divided on the many issues facing agriculture in Hawaii. Genetically modified organisms (GMO), pesticides, farm to school practices, food safety, land management, water rights, scarcity of fish, etc. are some of the issues that have divided the community.

The target populations to be served are K-12 public school students and the general public.

 The grant will provide the needed funds for HAF to expand its educational programs for public school students and the general public. The grant will build on its existing educational and outreach programs. Two years ago, HAF initiated three programs, Veggie U for fourth graders, Aquaponics for middle school students and In the Fields for high school students. With the grant HAF will reach out to partner with other local organizations such as the Hawaii Farm Bureau Federation and its national organization the American Farm Bureau Foundation for Agriculture, the Hawaii Seafood Council and the Hunting, Ranching and Fishing Organization. By partnering with other local and national agricultural educational organizations, HAF will maximize resources to provide public school teachers and the public with the best possible resources and information available.

HAF is proposing to develop the following programs:

Agriculture Education Program Expansion

Building on its current educational program, HAF will offer four workshops once a quarter for elementary, middle and high school teachers utilizing resources from the American Farm Bureau Foundation for Agriculture (AFBFA).

AFBFA has a plethora of well-designed educational materials that it offers free on its website to teachers. However, one of the challenges is navigating through the material and culling out the best educational pieces relevant to Hawaii and understanding how to best utilize those materials. HAF will contract a national trainer that will help teachers navigate through the AFBFA website of material and train teachers on how to use the materials. We plan to have a total of 100 teachers trained per quarter with one day dedicated to elementary, one day dedicated to middle school and two days dedicated to high school.

- b. Improve Results – We will secure evaluation of topics of discussion and improve the program with input from participants.

The Hawaii Agricultural Foundation has been in existence for the last six years. It has been successful in developing a number of initiatives including the Hawaii Food & Wine Festival, Kunia Ag Park, Localicious Hawaii and Lei Fresh. The HAF recently launched the Veggie U curriculum in over one hundred three classrooms statewide.

The HAF has a five-year strategic plan with priorities to develop its Educational Programs.

HAF currently operates a 184-acre agricultural park in Kunia for 19 farmers and has an office location on Waialae Avenue.

Prior to working for the HAF, Hayashi was a consultant to the Hawaii Farm Bureau Federation where she helped craft the language, vision and mission of the Foundation. She has more than eighteen years working as a consultant and executive with non-profit organizations specializing in strategic planning, fund development, marketing, government affairs, public relations and community relations. Her past employers and clients include NCL America, Bishop Museum, Japanese Cultural Center, Hawaii Foodbank, U.S. Senator Daniel K. Inouye, 3Rs, Artisans' Farmers Alliance, Durrant Media Five, Hawaii Institute for Public Affairs, Hawaii Farm Bureau Federation, Coast Guard Foundation, Hawaii Forest Industry Association, Hawaii Forest Institute, Hawaii High School Athletic Association, U.S.S. Battleship Missouri Association and the State of Hawaii Procurement Office. Highlights of her career include:

- Development of a long-term strategic planning for Hawaii Forest Institute
- Development of community relations strategies, key messaging and educational programs for NCL America
- Fund development, governmental relations and public relations strategies to secure funding support for Bishop Museum including the Mamiya Science Adventure Center, ADA facility compliance, Amy Greenwell Ethnobotanical Garden (Hawaii Island), a new Magnet School from the State, and Hawaiian Hall.

Iris Mizuguchi, Director of Educational Programs

Iris Mizuguchi currently oversees HAF's educational programs. She has more than 38 years working in the classroom and as an administrator for the Hawaii State Department of Education. Prior to her retirement in 2015, she held the position Education Specialist, Career and Technical Education where she oversaw all CTE activities inclusive of four student organizations (Family, Career and Community Leaders of America, National Future Farmers of America, Future Health Professionals and SkillsUSA). She was also responsible for managing the CTE state budget and eight district resource teachers.

Courtney Coston, Educational Manager

Courtney Coston currently manages the education programs of HAF, Ag in the Classroom and In the Fields. Prior to her tenure with HAF, she worked in San Antonio, Texas as a certified teacher for the North Independent School District. She worked for two years as middle school teacher teaching theatre arts, English and video and media. She also worked as the Educational Director of the Texas Shakespeare Festival where she managed the education program, recruited teachers for the program and created educational workshops.

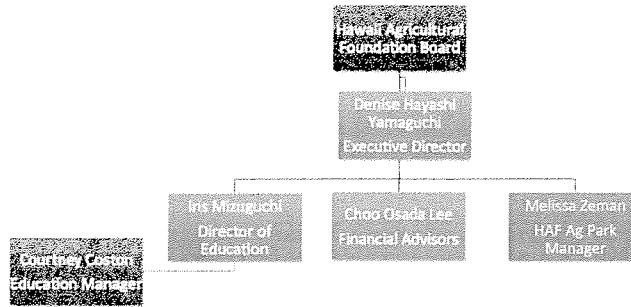
Melissa Zeman – HAF Ag Park at Kunia Property Manager

Melissa Zeman currently manages the Hawaii Agriculture Foundation (HAF) Ag Park at Kunia. Combining her experience in farming and agronomy with her knowledge of marketing and distributing produce, she is able to assist both new farmers and more experienced local producers. Forging a successful partnership between small farmers and large landowner is her goal as property manager, as well as assisting the Park's farmers in managing their day-to-day needs on the farm. Zeman serves on the board of the South O`ahu Soil and Water Conservation District and provides grant writing assistance to Sustain Pro Management, concentrating on agriculture and energy related projects. Zeman also began working with GreenWheel Food Hub in early 2013 as the market liaison at the Honolulu Farmers Market. GreenWheel Food Hub is working to implement EBT (food stamps) acceptance at farmers' markets on O`ahu and to use off grade and surplus produce in value-added processing to reduce waste. Zeman has an MSc in Environmental Science & Policy from Johns Hopkins University. She has also held various positions with O`ahu Resource Conservation & Development Council and Pioneer Hi Bred. She is also owner and founder of O`ahu Fresh, a local produce delivery company which brings affordable local fresh produce and specialty items to consumers who want to support local farmers.

Pursuant to Section 42F-103, Hawai'i Revised Statutes, for grants used for the acquisition of land, when the organization discontinues the activities or services on the land acquired for which the grant was awarded and disposes of the land in fee simple or by lease, the organization shall negotiate with the expending agency for a lump sum or installment repayment to the State of the amount of the grant used for the acquisition of the land.

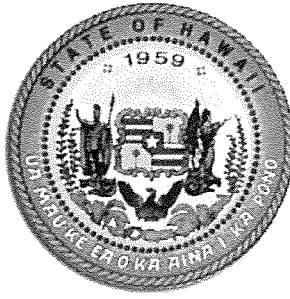
