A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Act 255, Session
- 2 Laws of Hawaii 2012, amended the definitions of "the practice of
- 3 nursing as a licensed practical nurse" and "the practice of
- 4 nursing as a registered nurse" to include carrying out the
- 5 orders of a licensed physician assistant practicing with
- 6 physician supervision as required by chapter 453, Hawaii Revised
- 7 Statutes, and acting as an agent of the supervising physician.
- 8 The Act included a sunset provision calling for the repeal of
- 9 the definitions on July 1, 2017; provided that the definitions
- 10 would be reenacted in the form in which they read on the day
- 11 prior to the Act's effective date.
- 12 The legislature further finds that there has been ample
- 13 time to evaluate the law and its effect on public health, and
- 14 there has been no harm. The change made by Act 255, Session
- 15 Laws of Hawaii 2012, has provided clarity and improved
- 16 communication for all health care providers and patients
- 17 impacted by the change.

4	SECTION 2. Act 255, Session Laws of Hawaii 2012, is

6	"SECTION 5. This Act shall take effect upon its approval
7	[and shall be repealed on July 1, 2017; provided that the
8	definitions of "the practice of nursing as a licensed practical
9	nurse" and "the practice of nursing as a registered nurse" under
10	section 457-2, Hawaii Revised Statutes, shall be reenacted in
11	the form in which they read on the day prior to the effective
12	date of this Act]."
13	SECTION 3. Statutory material to be repealed is bracketed
14	and stricken.
