A BILL FOR AN ACT

RELATING TO DRIVER LICENSING.

RE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 286-107, Hawaii Revised Statutes, is 1
- 2 amended to read as follows:
- 3 "\$286-107 License renewals; procedures and requirements.
- The examiner of drivers may accept an application for a 4
- renewal of a driver's license made not more than six months 5
- prior to the date of expiration. 6
- If, however, the renewal is not applied for within ninety 7
- days after the expiration of the license, the applicant for 8
- · 9 renewal shall be treated as an applicant for a new license and
- examined as provided in section 286-108. 10
- Except as otherwise provided in subsection (c), an 11
- applicant for a renewal of a driver's license under this 12
- 13 section, or the reactivation of an expired license under section
- 286-107.5(a), shall appear in person before the examiner of 14
- drivers and the examiner of drivers shall administer such 15
- physical examinations as the state director of transportation 16
- 17 deems necessary to determine the applicant's fitness to continue
- 18 to operate a motor vehicle.

 - (2) Has completed the same requirements as set forth in section 286-102.6(f) in another state and possesses a valid provisional license from that state; or
 - (3) Is at least eighteen years of age and who possesses a valid driver's license issued to the applicant in any jurisdiction for which the director has granted reciprocal licensing privileges in accordance with section 286-101.5 for the operation of vehicles in category (3) of section 286-102(b)."
