## A BILL FOR AN ACT

RELATING TO THE PENAL CODE.

## RE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 707-750, Hawaii Revised Statutes, is 1
- 2 amended by amending the definition of "sexual conduct" in
- 3 subsection (2) to read as follows:
- 4 ""Sexual conduct" means [acts of] actual or simulated
- 5 sexual intercourse, including genital-genital contact, oral-
- 6 genital contact, anal-genital contact, or oral-anal contact,
- 7 whether between persons of the same or opposite sex,
- 8 masturbation, [homosexuality, lesbianism,] bestiality, sexual
- 9 penetration, deviate sexual intercourse, sadomasochistic abuse,
- 10 or lascivious exhibition of the genital or pubic area of a
- 11 minor."
- 12 SECTION 2. Section 707-751, Hawaii Revised Statutes, is
- amended by amending the definition of "sexual conduct" in 13
- subsection (2) to read as follows: 14
- 15 ""Sexual conduct" means [acts of] actual or simulated
- sexual intercourse, including genital-genital contact, oral-**16**
- 17 genital contact, anal-genital contact, or oral-anal contact,

- 1 physical contact with a person's clothed or unclothed genitals,
- 2 pubic area, buttocks, or the breast or breasts of a female for
- 3 the purpose of sexual stimulation, gratification, or
- 4 perversion."
- 5 SECTION 5. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 6. This Act shall take effect upon its approval.
