## A BILL FOR AN ACT

RELATING TO WATER INFRASTRUCTURE LOANS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 155, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART II. WATER INFRASTRUCTURE LOANS
- 5 §155-A Definitions. As used in this part:
- 6 "Department" means the department of agriculture.
- 7 "Water infrastructure charge" means the on-bill charges for
- 8 the use and services of the loan program, including the
- 9 repayment of loans made under the loan program to be imposed on
- 10 water utility customers.
- 11 "Water infrastructure equipment" means infrastructure
- 12 improvements, equipment, and personal property to be installed
- 13 for dams, reservoirs, hydroelectric pumping, storm water
- 14 reclamation, ditch maintenance, spillways, wells, water ducts,
- 15 and water distribution systems.
- 16 "Water infrastructure loans" and "loan program" means the
- 17 program established by this part and loans made to finance the
- 18 purchase or installation of water infrastructure equipment for

- 1 dams, reservoirs, hydroelectric pumping, storm water
- 2 reclamation, ditch maintenance, spillways, wells, water ducts,
- 3 and water distribution systems.
- 4 "Water infrastructure special fund" means the special fund
- 5 created pursuant to section 155-D.
- 6 §155-B Hawaii water infrastructure loan program. There is
- 7 established a Hawaii water infrastructure loan program, which
- 8 shall be a loan program as defined under section 39-51. The
- 9 program shall be administered by the department in a manner
- 10 consistent with chapter 39, part III. This loan program may
- 11 include:
- 12 (1) Loans made, on terms approved by the department, to
- private entities, whether corporations, partnerships,
- 14 limited liability companies, or other persons, which
- entities may lease or provide water infrastructure
- 16 equipment to utility customers; and
- 17 (2) Direct loans to utility customers, on terms approved
- by the department.
- 19 §155-C Powers of the department. The department shall
- 20 have the following powers:

12		and proper for the implementation of the loan program;
13	(5)	Enter into contracts for the administration of the
14		loan program, in accordance with chapter 103D;
15	(6)	Establish loan program guidelines to carry out the
16		purposes of this part;
17	(7)	Perform all functions necessary to effectuate the
18		purposes of this part;
19	(8)	Delegate authority to the chairperson of the board of
20		agriculture to approve loans where the requested
21		amount plus any principal balance on existing loans to

1		the applicant does not exceed \$25,000 of state funds;

3	(9)	Adopt rules pursuant to chapter 91 necessary for the
4		purpose of this part.
5	§155	-D Hawaii water infrastructure special fund. (a)
6	There is	established the Hawaii water infrastructure special
7	fund into	which shall be deposited:
8	(1)	Water infrastructure charges received for the use and
9	·	services of the loan program, including the repayment
10		of loans made under the loan program;
11	(2)	All other funds received by the department and legally
12		available for the purposes of the water infrastructure
13		special fund;
14	(3)	Interest earnings on all amounts in the water
15		infrastructure special fund; and
16	(4)	Any other moneys permitted by the board of
17		agriculture.
18	(b)	Moneys in the water infrastructure special fund may be
19	used for	the purposes of:
20	(1)	Making water infrastructure loans;
21	(2)	Paying administrative costs of the loan program; or

- 1 (3) Paying any other costs related to the loan program."
- 2 SECTION 2. Chapter 155, Hawaii Revised Statutes, is
- 3 amended by amending the title of the chapter to read as follows:
- 4 "AGRICULTURAL [LOAN] AND WATER INFRASTRUCTURE LOANS"
- 5 SECTION 3. Chapter 155, Hawaii Revised Statutes, is
- 6 amended by designating sections 155-1 to 155-14 as part I and
- 7 inserting a title before section 155-1 to read as follows:
- 8 "PART I. AGRICULTURAL LOAN PROGRAM"
- 9 SECTION 4. There is appropriated out of the general
- 10 revenues of the State of 'Hawaii the sum of \$800,000 or so much
- 11 thereof as may be necessary for fiscal year 2016-2017 for
- 12 deposit into the Hawaii water infrastructure special fund.
- 13 There is appropriated out of the Hawaii water
- 14 infrastructure special fund the sum of \$800,000 or so much
- 15 thereof as may be necessary for fiscal year 2016-2017 for the
- 16 purposes of the fund.
- 17 The sum appropriated shall be expended by the department of
- 18 agriculture for the purposes of this Act.
- 19 SECTION 5. In codifying the new sections added by
- 20 section 1 of this Act, the revisor of statutes shall substitute

- 1 appropriate section numbers for the letters used in designating
- 2 the new sections in this Act.
- 3 SECTION 6. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 7. This Act shall take effect on July 1, 2016.
