Dear President Kouchi, Speaker Souki, and Members of the Legislature:

Re: HB2604 HD1 SD1 CD1

HB2604 HD1 SD1 CD1, entitled "A BILL FOR AN ACT RELATING TO THE ACQUISITION OF REAL PROPERTY" will become law without my signature, pursuant to Section 16 of Article III of the State Constitution.

The purpose of this bill is to resolve the disputed ownership of certain roads in the Kakaako Community Development District. This bill will amend Section 171-30, Hawaii Revised Statutes (HRS) to clarify that dedication of land by a private owner is sufficient to convey title to the state. Queen Street was dedicated to the territory in 1905 and the territorial legislature accepted the dedication but there is no deed or other document that contains an accurate description of exactly what was dedicated.

There is concern that these changes will bring inconsistencies with other provisions of Chapter 171, HRS, which excludes lands being used as roads and streets from the definition of public lands under the jurisdiction of the Board of Land and Natural Resources (Board). The Board has no road maintenance crews or equipment as there are no roads currently under the Boards jurisdiction. Ultimately, the Board might have to close these roads to the public and determine whether a disposition of the land would be suitable, such as for an easement or lease to private entities who could operate them and be responsible for the maintenance.

Finally, it could be argued that this bill becoming law would imply that Queen Street is not already a government road and compensation would be owed. As it stands now, the Attorney General believes it is clear that Queen Street is a city street pursuant to section 264-1, HRS.

For the foregoing reasons, HB2604 HD1 SD1 CD1 will become law as ACT 232 (16), Session Laws of Hawaii 2016, effective July 11, 2016, without my signature.

# A BILL FOR AN ACT

RELATING TO THE ACQUISITION OF REAL PROPERTY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 171-30, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows:
- 3 "(a) The board of land and natural resources shall have 4 the exclusive responsibility, except as provided herein, of 5 acquiring, including by way of dedications:
- 6 (1) All real property or any interest therein and the 7 improvements thereon, if any, required by the State 8 for public purposes, including real property together 9 with improvements, if any, in excess of that needed for such public use in cases where small remnants 10 11 would otherwise be left or where other justifiable 12 cause necessitates the acquisition to protect and 13 preserve the contemplated improvements, or public 14 policy demands the acquisition in connection with such 15 improvements.
  - (2) Encumbrances, in the form of leases, licenses, or otherwise on public lands, needed by any state

3	The board shall upon the request of and with the funds from
4	the state department or agency effectuate all acquisitions as
