A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Chapter 76, Hawaii Revised Statutes, is amended SECTION 1. 2 by adding a new section to be appropriately designated and to 3 read as follows: 4 Temporary employment in state positions. (a) No 5 department or agency of the State shall temporarily employ the 6 same person in the same position that is wholly funded by 7 general funds for more than two terms of eighty-nine days; 8 provided that with the approval of the governor, a department or 9 agency of the State may temporarily employ the same person in 10 the same position for eight terms of eighty-nine days within a 11 consecutive twenty-four-month period. (b) This section shall not apply to periods of temporary 12 employment when a person has been appointed to a vacant position 13 arising as a result of: 14 (1) A workers' compensation claim; 15 16 (2) Medical leave; 17 (3) An on-going investigation;
