## A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) The Hawaii invasive species council shall,
- 2 in coordination with the economic research organization at the
- 3 University of Hawaii, expand on the economic model formula that
- 4 establishes the impact and cost of mitigating the most
- 5 significant invasive species in the State.
- 6 (b) The Hawaii invasive species council shall submit a
- 7 report of the economic model formula to the legislature no later
- 8 than twenty days prior to the convening of the regular session
- **9** of 2017.
- 10 SECTION 2. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2015-2016 for
- 13 the Hawaii invasive species council to contract with the
- 14 economic research organization at the University of Hawaii for
- 15 services to establish an economic model formula that establishes
- 16 the impact and cost of mitigating the most significant invasive
- 17 species in the State.

- 1 The sum appropriated shall be expended by the Hawaii
- 2 invasive species council for the purposes of this Act.
- 3 SECTION 3. (a) The legislative reference bureau shall
- 4 update its 2002 study "Filling the Gaps in the Fight Against
- 5 Invasive Species" by reporting on:
- 6 (1) Mitigation and eradication efforts for the invasive
- 7 species identified in its report;
- **8** (2) Funding provided by the legislature since fiscal year
- 9 2002-2003 to assist in mitigation and eradication
- 10 efforts;
- 11 (3) The sufficiency of the funding; and
- 12 (4) The efficacy of the mitigation and eradication
- efforts.
- 14 (b) The Hawaii invasive species council shall cooperate
- 15 with the legislative reference bureau and provide the
- 16 legislative reference bureau with any information that is
- 17 required to complete the update.
- 18 (c) The legislative reference bureau shall submit the
- 19 updated component of its study to the legislature no later than
- 20 twenty days prior to the convening of the regular session of
- **21** 2017.

1 SECTION 4. This Act shall take effect on July 1, 2015.
