A BILL FOR AN ACT

RELATING TO INTERISLAND MOVEMENT OF INVASIVE SPECIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the interisland
- 2 spread of invasive species is harmful to agriculture, native
- 3 biota, public health, and the economic well-being of the State.
- 4 Further, the legislature finds that these pests continue to move
- 5 to new areas within the State through varied transportation
- 6 methods and on various agricultural and non-agricultural
- 7 commodities, which may or may not be subject to inspection for
- 8 pests or subject to treatment. The legislature further finds
- 9 that the plant quarantine branch of the department of
- 10 agriculture is a critical component in meeting the threat of
- 11 invasive species entering Hawaii and spreading throughout Hawaii
- 12 through the State's ports of entry.
- 13 To more effectively mitigate the spread of invasive
- 14 species, the Hawaii invasive species council and the biosecurity
- 15 program of the department of agriculture should use their
- 16 strengths and resources more efficiently. The Hawaii invasive
- 17 species council should direct the invasive species committees to

- 1 focus their resources on reducing invasive species in non-
- 2 agricultural areas, specifically conservation lands and
- 3 residential areas. The department of agriculture should focus
- 4 its resources on preventing the introduction of invasive species
- 5 into Hawaii and reducing invasive species in agricultural
- 6 production areas and performing inspections, certifications, and
- 7 treatments, if required.
- 8 SECTION 2. Section 150A-57, Hawaii Revised Statutes, is
- 9 amended to read as follows:

- 11 submit an annual report on the biosecurity program to the
- 12 legislature no later than twenty days prior to the convening of

- 3 The sum appropriated shall be expended by the department of
- 4 agriculture for the purposes of this Act.
- 5 SECTION 5. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$800,000 or so much
- 7 thereof as may be necessary for fiscal year 2016-2017 for the
- 8 purposes set forth in section 3(2) of this Act.
- 9 The sum appropriated shall be expended by the department of
- 10 agriculture for the purposes of this Act.
- 11 SECTION 6. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 13 thereof as may be necessary for fiscal year 2016-2017 for the
- 14 planning, site selection, preparation of environmental
- 15 documentation, and preliminary design for two facilities;
- 16 provided that one facility shall be for edible agricultural
- 17 crops and the other shall be for non-edible agricultural crops
- 18 for the purpose of marshalling and treatment of commodities
- 19 prior to the interisland movement or export from the island of
- 20 Hawaii.

- 1 The sum appropriated shall be expended by the department of
- 2 agriculture for the purposes of this Act.
- 3 SECTION 7. There is appropriated from the general revenues
- 4 of the State of Hawaii the sum of \$100,000 or so much thereof as
- 5 may be necessary for fiscal year 2016-2017 for the auditor to
- 6 conduct a financial and performance audit of the duties and
- 7 facilities of the plant quarantine branch of the department of
- 8 agriculture, including the branch's biosecurity programs and
- 9 related programs; provided that the auditor shall submit a
- 10 report of findings and recommendations, including proposed
- 11 legislation, to the governor and the legislature no later than
- 12 twenty days prior to the convening of the regular session of

- 14 The sum appropriated shall be expended by the department of

- 17 and stricken. New statutory material is underscored.
- 18 SECTION 9. This Act shall take effect on July 1, 2016.
