## A BILL FOR AN ACT

RELATED TO ELECTIONS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 303 of the Help America Vote Act of  
2 2002 requires applicants for voter registration for federal  
3 office elections to provide a driver's license number, if one  
4 has been issued, or if none has been issued, the last four  
5 digits of the applicant's social security number.

6           The legislature finds that Hawaii should conform state  
7 election law for voter registration to the same requirements of  
8 the federal office election law because the voting registration  
9 law in Hawaii does not distinguish between voter registration  
10 for state or federal office.

11           The purpose of this Act is to require the applicant's  
12 Hawaii driver's license number or Hawaii state identification  
13 card number for purposes of voter registration or, if no license  
14 or identification card has been issued, the last four digits of  
15 the applicant's social security number.

16           SECTION 2. Section 11-15, Hawaii Revised Statutes, is  
17 amended by amending subsection (a) to read as follows:



1           (a) Any person qualified to and desiring to register as a  
2 voter in any county shall make and subscribe to an application  
3 in the form of an affidavit.

4           The affidavit shall contain the following information:

5           (1) Name;

6           (2) ~~[Social security number,]~~ The applicant's Hawaii  
7 driver's license number or Hawaii state identification  
8 card number or, if no license or identification card  
9 has been issued, the last four digits of the  
10 applicant's social security number;

11          (3) Date of birth;

12          (4) Residence, including mailing address;

13          (5) That the residence stated in the affidavit is not  
14 simply because of the person's presence in the State,  
15 but that the residence was acquired with the intent to  
16 make Hawaii the person's legal residence with all the  
17 accompanying obligations therein; and

18          (6) That the person is a citizen.

19           An application to register to vote shall include a space to  
20 request a permanent absentee ballot."
