A BILL FOR AN ACT

RELATING TO SOLID WASTE REDUCTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State should
- 2 lead by example while moving toward a more environmentally
- 3 sustainable future. An effective way to increase environmental
- 4 sustainability is to diminish the need for landfills by
- 5 diverting food waste and green waste from landfills to
- 6 composting and energy generation.
- 7 The purpose of this Act is to continue the progress toward
- 8 long-term environmental sustainability by authorizing the Hawaii
- 9 public housing authority to enter into contracts with private
- 10 businesses to remove food waste and green waste from the waste
- 11 stream for use in other business sectors, including agriculture
- 12 and energy generation.
- 13 SECTION 2. Section 356D-4, Hawaii Revised Statutes, is
- 14 amended by amending subsection (a) to read as follows:
- 15 "(a) The authority may:
- 16 (1) Sue and be sued;
- 17 (2) Have a seal and alter the same at pleasure;
