A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's government
- 2 should operate as efficiently as possible to make the best use
- 3 of government resources, personnel, and taxpayer dollars as it
- 4 works to achieve the policy goals enacted by the legislature on
- 5 behalf of the people of Hawaii. However, natural resource and
- 6 environmental management is split among many departments and
- 7 agencies, often leading to inefficiencies. For example, the use
- $oldsymbol{8}$ and protection of water resources is scattered among the
- 9 environmental health administration and the clean water branch
- 10 of the department of health, the division of aquatic resources,
- 11 the commission on water resource management, the office of
- 12 conservation and coastal lands, the division of boating and
- 13 ocean recreation of the department of land and natural
- 14 resources, and the coastal zone management program of the office
- 15 of planning of the department of business, economic development
- 16 and tourism, to name a few.
- 17 The legislature also finds that several departments also
- 18 suffer from internal conflicts of interest, including the



- 1 department of land and natural resources, which is tasked to
- 2 preserve Hawaii's public lands as well as make them available
- 3 for other purposes.
- 4 The legislature further finds that because the scope and
- 5 mission of some departments is so broad, directors must
- 6 prioritize their requests for resources. Inevitably, some
- 7 programs and services outside a department's core mission are
- 8 left behind. These programs and services may be a better fit in
- 9 another department where they take a higher priority.
- 10 In addition, modern critical issues such as climate change
- 11 necessitate that action and responsibility be spread among
- 12 several departments. It is sometimes unclear which departments
- 13 will take the lead and which will be responsible for using their
- 14 limited resources to tackle these challenges.
- The legislature finds that in 1984, the legislature adopted
- 16 Senate Concurrent Resolution No. 135 and House Concurrent
- 17 Resolution No. 78, requesting the legislative reference bureau
- 18 to conduct a study of establishing a state environmental
- 19 protection agency, department, or comparable body to coordinate
- 20 and address matters of environmental quality. In 1985, the
- 21 legislative reference bureau released a study "The Feasibility

- 1 of Environmental Reorganization for Hawaii", which, in part,
- 2 discussed the creation of a state department of environmental
- 3 protection.
- 4 The legislature further finds that Act 293, Session Laws of
- 5 Hawaii 1991, temporarily placed a department of environmental
- 6 protection in the Hawaii Revised Statutes; however the Act also
- 7 provided for its repeal on July 1, 1992, if the legislature
- 8 failed to enact a bill establishing the powers, duties, and
- 9 other provisions of the department of environmental protection
- 10 during the regular session of 1992. The department of
- 11 environmental protection task force report, in response to Act
- 12 293, found that while there was consensus that a department of
- 13 environmental protection should be established, the task force
- 14 could not reach consensus on the strategy regarding the overall
- 15 establishment of the department. The legislature was not able
- 16 to enact a law establishing the powers, duties, and other
- 17 provisions of the department of environmental protection, and
- 18 thus, Act 293 was repealed.
- 19 The purpose of this Act is to require the legislative
- 20 reference bureau to update the 1985 study "The Feasibility of

- 1 Environmental Reorganization for Hawaii" and to assess the
- 2 feasibility of implementing findings and recommendations.
- 3 SECTION 2. (a) The legislative reference bureau shall
- 4 update its study "The Feasibility of Environmental
- 5 Reorganization for Hawaii" and assess the feasibility of
- 6 implementing the findings and recommendations of the department
- 7 of environmental protection task force.
- **8** (b) The legislative reference bureau may contract the
- 9 services of another entity to perform any related services that
- 10 may be required pursuant to this Act. Any contract for services
- 11 executed pursuant to this Act shall be exempt from chapter 103D,
- 12 Hawaii Revised Statutes.
- 13 (c) The legislative reference bureau shall submit the
- 14 updated study to the legislature no later than twenty days prior
- 15 to the convening of the regular session of 2016.
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2015-2016 for
- 19 the purposes of this Act.
- The sum appropriated shall be expended by the legislative
- 21 reference bureau for the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2015.
