A BILL FOR AN ACT

RELATING TO THE RENTAL HOUSING TRUST FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 201H, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§201H- County rental housing subaccounts. (a) The
- 5 corporation, upon request by a county, may establish and operate
- 6 a rental housing subaccount for the benefit of the county within
- 7 the rental housing trust fund.
- **8** (b) Matching loans and contributions of up to \$5,000,000
- 9 may be made by the county and the rental housing trust fund into
- 10 a county rental housing subaccount.
- 11 (c) The county shall agree in writing to indemnify,
- 12 defend, and hold harmless the corporation, its officers, agents,
- 13 and employees from and against any and all claims arising out of
- 14 or resulting from activities carried out or projects undertaken
- 15 with any loan or grant made from a county rental housing
- 16 subaccount.

- 1 (d) An amount from the county rental housing subaccount,
- 2 to be set by the corporation and authorized by the legislature,
- 3 may be used for administrative expenses incurred by the
- 4 corporation in administering the subaccount.
- 5 (e) The corporation shall adopt rules in accordance with
- 6 chapter 91 relating to the establishment, requirements, and
- 7 operation of county rental housing subaccounts."
- 8 SECTION 2. Section 201H-202, Hawaii Revised Statutes, is
- 9 amended by amending subsection (d) to read as follows:
- 10 "(d) The fund shall be used to provide loans or grants for
- 11 the development, pre-development, construction, acquisition,
- 12 preservation, and substantial rehabilitation of rental housing
- 13 units. Permitted uses of the fund may include but are not
- 14 limited to planning, design, land acquisition, costs of options,
- 15 agreements of sale, downpayments, equity financing, capacity
- 16 building of nonprofit housing developers, or other housing
- 17 development services or activities as provided in rules adopted
- 18 by the corporation pursuant to chapter 91. The rules may
- 19 provide for a means of recapturing loans or grants made from the
- 20 fund if a rental housing project financed under the fund is
- 21 refinanced or sold at a later date. The rules may also provide

- 1 that moneys from the fund shall be leveraged with other
- 2 financial resources to the extent possible. Subject to the
- 3 provisions of this section, the proceeds in the fund may also be
- 4 used for the purposes of establishing and operating the county
- 5 rental housing subaccounts described in section 201H- ."
- 6 SECTION 3. New statutory material is underscored.
- 7 SECTION 4. This Act shall take effect on July 1, 2015.
