A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR A MARINE REGULATION AND POLICY SPECIALIST.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the division of
- 2 aquatic resources within the department of land and natural
- 3 resources is legislatively mandated to "manage and administer
- 4 aquatic life and aquatic resources of the State. " The primary
- 5 way that the division of aquatic resources carries out this
- 6 mandate is through the adoption and enforcement of
- 7 administrative rules. The legislature also finds that aside
- 8 from being severely understaffed, the division lacks the
- 9 necessary technical capacity to effectively develop, interpret,
- 10 and apply the laws that it is tasked with administering.
- 11 Specifically, there are no positions designated and adequately
- 12 equipped to write, review, and amend administrative rules. As a
- 13 result, many existing marine resource laws are outdated, ridden
- 14 with loopholes, difficult or impossible to enforce, and in need
- 15 of revision. The legislature also finds that the increase in

- 1 ocean use necessitates the development of new and innovative
- 2 regulations.
- 3 The legislature further finds that the establishment of a
- 4 marine regulation and policy specialist position within the
- 5 division will fulfill this critical function of drafting,
- 6 reviewing, and amending administrative rules to better manage
- 7 and protect the State's marine resources. The position will
- 8 also collaborate with the office of the attorney general to
- 9 provide additional legal support for the division's programs,
- 10 projects, and activities and will streamline the development and
- 11 implementation of marine resource management measures.
- The purpose of this Act is to create a position in the
- 13 division of aquatic resources of the department of land and
- 14 natural resources to ensure compliance with state and federal
- 15 mandates and support effective rulemaking and administrative
- 16 enforcement actions for resource damage.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so
- 19 much thereof as may be necessary for fiscal year 2015-2016 and
- 20 the same sum or so much thereof as may be necessary for fiscal
- 21 year 2016-2017 for the establishment of one full time-time

- 1 equivalent (1.00 FTE) permanent marine regulation and policy
- 2 specialist position in the division of aquatic resources of the
- 3 department of land and natural resources to ensure compliance
- 4 with state and federal mandates and support effective rule-
- 5 making and administrative enforcement actions for resource
- 6 damage.
- 7 The sums appropriated shall be expended by the department
- 8 of land and natural resources for the purposes of this Act.
- 9 SECTION 3. This Act shall take effect on July 1, 2015.
