A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

. 1	SECT	ION 1. The legislature finds that community health
2	centers s	erve uninsured, underinsured, low-income patient
3	populatio	ns with demographic complexities and co-morbidities, in
4	addition	to one-fourth of the State's medicaid members, and much
5	of the St	ate's homeless population. Community health centers:
6	(1)	Are nonprofit, community-based organizations whose
7		purpose and expertise lie in providing quality person-
8		centered health care to underserved populations and
9		areas;
10	(2)	Provide culturally and linguistically appropriate
11		health care and a broad range of integrated primary
12		care and preventive services;
13	(3)	Operate in medically-underserved areas where people
14		have limited access to other health care providers
15		because of geographic and socio-economic barriers;
16	(4)	Contribute greatly to the economies and livability of
17		the communities they serve; and

1	(5) Are cost-effective quality health care providers whose		
2	care results in healthier patients and decreased use		
3	of emergency, specialty, and inpatient services.		
4	Community health centers save the health care system \$1,263		
5	per patient per year due to timely, effective care and care		
6	management that reduces unnecessary emergency room, inpatient,		
7	and specialty utilization. This translated to savings of more		
8	than \$90,000,000 for Hawaii's medicaid program in 2013. Their		
9	patient-centered delivery system features comprehensive primary		
10	medical, behavioral-health, and dental services; care management		
11	and enabling services that enhance access, compliance, and		
12	patient engagement; and focus on quality outcomes supported by		
13	electronic health records that conform to meaningful use		
14	requirements. Community health centers are smart investments		
15	that result in healthier communities while saving the State		
16	money.		
17	The legislature further finds that it is in the best		
18	interest of the State to ensure access to primary, behavioral,		
19	dental, and preventive health care for its residents. In		
20	addition to facilitating a healthier population, improving		
21	access to health care reduces state expenditures attributable to		

- 1 hospital and emergency room services for preventable injuries or
- 2 illnesses.
- 3 SECTION 2. The legislature finds that the State's
- 4 federally matched medicaid and med-QUEST programs form an
- 5 essential support for underserved individuals and for community
- 6 health centers. Among the medicaid programs that need to be
- 7 fully funded are dental benefits for adults and outreach and
- 8 enrollment services.
- 9 Oral health is as important as any other physical or mental
- 10 health need, and dental diseases contribute to cardiac issues
- 11 and premature births. Unaddressed dental needs affect the
- 12 ability of individuals to obtain and keep employment.
- 13 Med-QUEST programs offer insurance options for low-income
- 14 uninsured citizens. Under the federal Patient Protection and
- 15 Affordable Care Act of 2010, such programs expanded to
- 16 accommodate additional uninsured adults. It is in the best
- 17 interest of the State to ensure that community programs reach
- 18 out to and assist individuals and families with children to
- 19 enroll in med-QUEST programs and other social support programs
- 20 for which they are eligible.

1 Accordingly, the purpose of this Act is to provide quality, 2 cost-effective health care for Hawaii residents who are uninsured, newly uninsured, underinsured, potential medicaid 3 4 enrollees, or medicaid enrollees. 5 SECTION 3. There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$4,800,000 or so much 7 thereof as may be necessary for fiscal year 2015-2016 and the 8 same sum or so much thereof as may be necessary for fiscal year 9 2016-2017 to restore basic adult dental benefits to medicaid 10 enrollees. The department of human services shall obtain the 11 maximum federal matching funds available for this expenditure. 12 The sums appropriated shall be expended by the department of human services for the purposes of this section. 13 14 SECTION 4. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$800,000 or so much 16 thereof as may be necessary for fiscal year 2015-2016 and the 17 same sum or so much thereof as may be necessary for fiscal year 18 2016-2017 to provide outreach and eligibility services, 19 including medicaid and children's health insurance program 20 eligibility, for children, families, and individuals at 21 federally qualified health centers. The department of human

- 1 services shall obtain the maximum federal matching funds
- 2 available for this expenditure.
- 3 The sums appropriated shall be expended by the department
- 4 of human services for the purposes of this section.
- 5 SECTION 5. There is appropriated out of the community
- 6 health centers special fund the sum of \$1,000,000 or so much
- 7 thereof as may be necessary for fiscal year 2015-2016 and the
- 8 same sum or so much thereof as may be necessary for fiscal year
- 9 2016-2017 to the department of health to be transferred to the
- 10 department of human services and expended to establish health
- 11 care homes for medicaid enrollees at federally qualified
- 12 community health centers as provided in the federal Patient
- 13 Protection and Affordable Care Act of 2010. The department of
- 14 human services shall obtain the maximum federal matching funds
- 15 available for this expenditure.
- The sums appropriated shall be expended by the department
- 17 of human services for the purposes of this section.
- 18 SECTION 6. This Act shall take effect on July 1, 2015.
