

A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The State has a vested interest in increasing

2 the amount of local food grown and consumed in Hawaii. One

3 avenue is for the State to find opportunities to purchase more

4 local food through its procurement policies. These policies

5 will help to increase food self-sufficiency and make Hawaii more

6 economically secure. For local farmers, this avenue can provide

7 an additional market avenue to sell more products, thereby

8 providing the local agricultural sector with more revenue and

9 jobs. Furthermore, increasing the consumption of locally grown

10 foods will ensure that fresh, high quality produce is available

11 for healthy meals in schools, hospitals, and correctional

12 facilities throughout the State. Our children will be able to

13 eat the highest quality food that will nourish their bodies,

14 enhance their educational experience, cultivate long-term

15 healthy habits, and reconnect them with the origins of their

16 food.

1	The purpose of this Act is to establish a task force to	
2	create re	commendations for increasing procurement of food grown
3	in Hawaii	by state departments and agencies.
4	SECT	ION 2. (a) There shall be established within the
5	state pro	curement office, for administrative purposes only, a
6	Hawaii-gr	own food procurement task force.
7	(b)	The task force shall:
8	(1)	Research and identify challenges of increasing
9		procurement of local foods from industry experts such
10		as regulators, farmers, distributors, cafeteria
11		managers, health officials, or any other expert as
12		deemed necessary by the task force;
13	(2)	Develop recommendations for statewide policies and
14		implement procedures for increasing local food
15		procurement in schools;
16	(3)	Develop recommendations for statewide policies and
17		implement procedures for increasing local food
18		procurement in hospitals;
19	(4)	Develop recommendations for statewide policies and
20		implement procedures for increasing local food
21		procurement in prisons;

1	(5)	Develop recommendations for statewide policies and
2		implement procedures for increasing local food
3		procurement in any state department or agency deemed
4		feasible by the task force; and
5	(6)	Recommend a framework for collecting data to track
6		procurement contracts such that the results from the
7		task force can be measured over time. This shall
8		include working with all the State's procurement
9		officers to standardize the tracking of awards made
10		and the rationale for the award in order to measure
11		and quantify outcomes.
12	(c)	The task force shall adopt rules and procedures as
13	needed.	Task force membership shall consist of at least one
14	represent	ative from each of the following:
15	(1)	The state procurement office;
16	(2)	The department of agriculture procurement office;
17	(3)	The department of education procurement and contracts
18		branch;
19	(4)	The department of education food services branch;
20	(5)	The department of public safety procurement branch;
21	(6)	The department of human services procurement branch;

- 1 (7) Any other interested departmental procurement branch;
- 2 (8) Stakeholders from the farm-to-school movement;
- 3 (9) The United States Department of Agriculture;
- 4 (10) Hawaii Farm Bureau Federation;
- 5 (11) Hawaii Farmer's Union;
- 6 (12) The Hawaii State Teachers Association;
- 7 (13) Local food distributors, including those from counties
- 8 with a population of less than five hundred thousand;
- 9 (14) Ulupono Initiative; and
- 10 (15) The office of information management and technology.
- 11 The representative from the state procurement office shall
- 12 serve as the task force chairperson.
- 13 (d) The task force shall submit a report of its findings
- 14 and recommendations, including any proposed legislation, to the
- 15 legislature no later than twenty days prior to the convening of
- 16 the regular session of 2016.
- 17 (e) The task force shall be dissolved on June 30, 2016.
- 18 SECTION 3. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of S or so
- 20 much thereof as may be necessary for fiscal year 2015-2016 to
- 21 fund the Hawaii-grown food procurement task for the purpose of

- 1 creating recommendations for increasing procurement of food

- 3 The sum appropriated shall be expended by the state
- 4 procurement office for the purposes of this Act.
- 5 SECTION 4. This Act shall take effect on July 1, 2015.
