A BILL FOR AN ACT

RELATING TO HAWAIIAN LANGUAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaiian
- 2 language college at the University of Hawaii at Hilo requires a
- 3 broader income base to better fund its operations, services, and
- 4 outreach program. The Hawaiian language college has established
- 5 the first master's program, first doctoral program, first
- 6 teacher education program, and first preschool through grade
- 7 twelve laboratory school program in Hawaiian or in any Native
- 8 American language. The Hawaiian language support center is the
- 9 primary provider of curriculum materials in the Hawaiian
- 10 language, on-line materials in the Hawaiian language, in-service
- 11 training through the Hawaiian language, Hawaiian lexicon
- 12 development and dissemination, Hawaiian language American
- 13 Council on the Teaching of Foreign Languages proficiency
- 14 testing, and Hawaiian language medium college courses for high
- 15 school students in the State.
- 16 Annually, the indigenous language outreach program draws
- 17 many visitors from other states and countries. These visitors

- 1 request various services and products relating to language
- 2 revitalization and the use of indigenous languages in education
- 3 rooted in the science of linguistics. Section 304A-2270, Hawaii
- 4 Revised Statutes, established the Hawaiian language college
- 5 revolving fund to provide funds for the college, but only
- 6 provides for deposits into the fund from sales of Hawaiian
- 7 language materials. The Hawaiian language college provides many
- 8 other services and products for which fees are traditionally
- 9 charged, and allowing such fees to be deposited into the
- 10 Hawaiian language college revolving fund would help the Hawaiian
- 11 language college do even more in the field of indigenous
- 12 languages and provide a wider range of services and products.
- 13 The purpose of this Act is to expand the scope of the
- 14 Hawaiian language college revolving fund to allow any funds
- 15 generated by the Hawaiian language college, Hawaiian language
- 16 support center, and indigenous outreach program through fees for
- 17 services, training, and all products to be deposited into the
- 18 revolving fund and expended at the discretion of the Hawaiian
- 19 language college.
- 20 SECTION 2. Section 304A-2270, Hawaii Revised Statutes, is
- 21 amended to read as follows:

- 1 "[+] §304A-2270[+] Hawaiian language college revolving
- 2 fund. There is established the Hawaiian language college
- 3 revolving fund into which revenues [from the sale of Hawaiian
- 4 language materials generated by the Hawaiian language college,
- 5 Hawaiian language support center, and indigenous outreach
- 6 program through fees for services, training, and the sale of all
- 7 products shall be deposited. Moneys deposited into this fund
- 8 shall be expended at the discretion of the Hawaiian language
- 9 college to support the Hawaiian language college at the
- 10 University of Hawaii at Hilo established under section [4]304A-
- **11** 1301 [+]."
- 12 SECTION 3. Statutory material to be repealed is bracketed
- 13 and stricken. New statutory material is underscored.
- 14 SECTION 4. This Act shall take effect upon its approval.
