### A BILL FOR AN ACT

RELATING TO VOTING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 11-11, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "S11-11 Registration. A person who registers as required
- 4 by law shall be entitled to vote at any election provided that
- 5 the person shall have attained the age of [eighteen] sixteen at
- 6 the time of that election. The county clerk shall be
- 7 responsible for voter registration in the respective counties
- 8 and the keeping of the general register and precinct lists
- 9 within the county."
- 10 SECTION 2. Section 11-12, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- 12 "§11-12 Age; place of registering. (a) Every person who
- 13 has reached the age of [eighteen] sixteen years or who is
- 14 [seventeen] fifteen years of age and will be [eighteen] sixteen
- 15 years of age by the date of the next election, and is otherwise
- 16 qualified to register may do so for that election. The person
- 17 shall then be listed upon the appropriate county general

- 1 register and precinct list. No person shall register or vote in
- 2 any other precinct than that in which the person resides except
- 3 as provided in section 11-21.
- 4 (b) A person who is otherwise qualified to register and is
- 5 at least [sixteen] fourteen years of age but will not be
- 6 [eighteen] sixteen years of age by the date of the next election
- 7 may preregister upon satisfactory proof of age and shall be
- 8 automatically registered upon reaching age [eighteen.] sixteen."
- 9 SECTION 3. Section 11-15.5, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- "[f] \$11-15.5[f] Duties of all state agencies; voter
- 12 registration. Each state agency that deals with the public
- 13 shall make available to each member of the public [eighteen]
- 14 sixteen years of age or older an application in the form of an
- 15 affidavit for voter registration pursuant to section 11-15. The
- 16 application shall be available by mail or in person depending on
- 17 the manner in which the agency's services are requested by the
- 18 person. The form of the application may be identical to that
- 19 described and found in public telephone directories."
- 20 SECTION 4. Section 13D-3, Hawaii Revised Statutes, is
- 21 amended by amending subsections (a) and (b) to read as follows:

- 14 and stricken. New statutory material is underscored.
- 15 SECTION 6. This Act shall take effect upon its approval
- 16 and upon ratification of a constitutional amendment amending the
- 17 qualifying age of voters for any state or local election to
- 18 sixteen years of age.
